Chair Lund called the meeting to order.

Rep. McBroom moved to approve the minutes of the meeting held June 28, 2011. The motion prevailed.

Chair Lund laid before the Committee SB 584 - Richardville - Elections; primary; presidential election date; revise.

Rep. Stanley moved to adopt the substitute H-1 to SB 584. The motion did not prevail, the vote being 3-6-0.
