- 1 SEC. 1255A. (1) SUBJECT TO SUBSECTION (2), IF THE BOARD OF A

- 3 DIRECTORS OF A PUBLIC SCHOOL ACADEMY OFFERS A MEDICAL BENEFIT PLAN

- 5 (A) FOR THE 2011-2012 SCHOOL FISCAL YEAR, THE BOARD OR BOARD
- 6 OF DIRECTORS SHALL ENSURE THAT THE SCHOOL DISTRICT, INTERMEDIATE
- 7 SCHOOL DISTRICT, OR PUBLIC SCHOOL ACADEMY DOES NOT PAY ON BEHALF OF
- 8 AN EMPLOYEE MORE THAN 80% OF THE TOTAL ANNUAL COST OF THE MEDICAL
- BENEFIT PLAN FOR THAT EMPLOYEE FOR THAT SCHOOL FISCAL YEAR.

- 21 (B) "MEDICAL BENEFIT PLAN" MEANS A PLAN ESTABLISHED AND
- 22 MAINTAINED BY A CARRIER OR 1 OR MORE SCHOOL DISTRICTS, INTERMEDIATE
- 23 SCHOOL DISTRICTS, OR PUBLIC SCHOOL ACADEMIES THAT PROVIDES FOR THE
- 24 PAYMENT OF MEDICAL, OPTICAL, OR DENTAL BENEFITS, INCLUDING, BUT NOT
- 25 LIMITED TO, HOSPITAL AND PHYSICIAN SERVICES, PRESCRIPTION DRUGS,
- 26 AND RELATED BENEFITS, TO EMPLOYEES.
