Senate Committee on Outdoor Recreation and Tourism
Minutes

A meeting of the Senate Committee on Outdoor Recreation and Tourism was held on Thursday, June 6, 2013 at 12:30 p.m. in Room 110 of the Farnum Building.

The meeting was called to order at 12:34 p.m.

Members present: Senators Hansen, Hildenbrand, Meekhof, Casperson, Moolenaar, Young, Hopgood

Senator Hansen called the meeting to order.

Senator Hansen announced the order of business for the day:

- Approval of the Minutes
- HB 4094 (Rep. Johnson)-- Natural resources; hunting; punishment for taking game in another state; prohibit.

Senator Meekhof moved to adopt the committee minutes from March 20, 2013 by unanimous consent. Without any objection, the minutes were adopted.

Senator Hansen placed before the committee House Bill 4094 (Rep. Johnson). Ben Frederick, staff to Representative Johnson, explained the bill to members and answered questions.

Senators Casperson and Moolenaar entered the committee room at 12:36 p.m.

Senator Hildenbrand moved that House Bill 4094 be reported out of committee with the recommendation that the bill then pass. The motion prevailed by an affirmative vote of a majority of the members appointed to and serving on the committee, voting as follows:
