Senate Committee on Outdoor Recreation and Tourism
Minutes

A meeting of the Senate Committee on Outdoor Recreation and Tourism was held on Thursday, September 18, 2014 at 12:30 p.m. in Room 110 of the Farnum Building.

The meeting was called to order at 12:34 p.m.

Present: Senators Hansen (C), Hildenbrand, Meekhof, Moolenaar, Young and Hopgood

Absent/Excused: Senator Casperson

Senator Meekhof moved to adopt the committee minutes from March 27, 2014. Without any objection, the minutes were adopted.

Senator Hildenbrand moved to excuse absent members. Without any objection, absent members were excused.
