**1** Sec. 4701. As used in this chapter:

18 the commission of a crime, including any appreciation in the value

20 (e) "Security interest" means any interest in real or personal21 property that secures payment or performance of an obligation.

(f) "Substituted proceeds of a crime" means any property
obtained or any gain realized by the sale or exchange of proceeds
of a crime.
