

HOUSE BILL No. 4045

January 22, 2013, Introduced by Rep. Crawford and referred to the Committee on Regulatory Reform.

A bill to amend 1956 PA 217, entitled "Electrical administrative act," by amending sections 3e and 3h (MCL 338.883e and 338.883h), section 3e as added by 1990 PA 246 and section 3h as added by 1992 PA 130.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 3e. (1) An individual employed as an apprentice
2 electrician shall register with the board on a form provided by the
3 board within 30 days after employment.

4 (2) The department of ~~labor~~ **LICENSING AND REGULATORY AFFAIRS**
5 shall issue a certificate of registration to a person seeking
6 registration ~~upon~~ **IF IT RECEIVES** satisfactory proof of the person's
7 participation in a bona fide apprenticeship training program
8 approved by the board. ~~This program shall be equivalent to the~~
9 ~~requirements of those imposed by the United States department of~~

1 ~~labor bureau of apprenticeship and training, subject to subsection~~

3 (3) Except as otherwise provided in subsection (4), the ratio
4 of electrical journeymen or master electricians to registered
5 apprentice electricians shall be on the basis of 1 electrical
6 journeyman or master electrician to 1 registered apprentice
7 electrician. The department of ~~labor~~**LICENSING AND REGULATORY**
8 **AFFAIRS** or an enforcing agency shall enforce the ratio on a jobsite
9 basis.

10 (4) Notwithstanding subsection (3), in the case of a
11 residential single family dwelling or a multifamily dwelling not
12 exceeding 8 units per building, the department of ~~labor~~**LICENSING**
13 **AND REGULATORY AFFAIRS** or an enforcing agency shall enforce the
14 apprentice electrician ratio on the basis of 1 electrical
15 journeyman or master electrician to 2 registered apprentice
16 electricians on a jobsite basis.

17 Sec. 3h. (1) An individual employed as a fire alarm specialty
18 apprentice technician shall register with the board on a form
19 provided by the board within 30 days after employment.

20 (2) The department of ~~labor~~**LICENSING AND REGULATORY AFFAIRS**
21 shall issue a certificate of registration to a person seeking
22 registration ~~upon~~**IF IT RECEIVES** satisfactory proof of the person's
23 participation in a bona fide apprenticeship training program
24 approved by the board. ~~This program shall be equivalent to the~~

1 (3) The ratio of fire alarm specialty technicians to
2 registered fire alarm specialty apprentice technicians shall be on
3 the basis of 1 fire alarm specialty technician to 2 registered fire
4 alarm specialty apprentice technicians. The department of ~~labor~~
5 **LICENSING AND REGULATORY AFFAIRS** or an enforcing agency shall
6 enforce the ratio on a jobsite basis.
