- 11 (E) (d) "Firefighter" means a regularly employed member of a
- 12 fire department of a city, county, township, village, state
- 13 university, or community college or a member of the department of
- 14 natural resources who is employed to fight fires. Firefighter
- 15 includes a volunteer member of a fire department.
- (F) (e) "Law enforcement officer" means an individual involved
- 17 in crime and juvenile delinquency control or reduction or
- 18 enforcement of the criminal law. Law enforcement officer includes
- 19 police, corrections, probation, parole, bailiffs, or other similar
- 20 court officers.
- 21 (G) (f) "Line of duty" means either of the following:
- (i) Any action which an officer whose primary function is crime
- 23 control or reduction, enforcement of the criminal law, or
- 24 suppression of fires is obligated or authorized by rule,
- 25 regulations, condition of employment or service, or law to perform,
- 26 including those social, ceremonial, or athletic functions to which
- 27 the officer is assigned, or for which the officer is compensated,

- (I) (h) "Permanent and total disability" means medically

- 14 that permanently prevent a former public safety officer from

- 17 individual serving a public agency in an official capacity, with or

- 2 DEPENDENTS HEALTH INSURANCE COMPARABLE TO, AND ON COMPARABLE TERMS
- 3 TO, THE INSURANCE COVERAGE THE DECEDENT RECEIVED FROM ANY SOURCE AT
- 4 THE TIME OF HIS OR HER DEATH. COVERAGE PROVIDED UNDER THIS SECTION
- 5 ENDS FOR A SPOUSE IF HE OR SHE QUALIFIES FOR AND OBTAINS COMPARABLE
- 6 HEALTH INSURANCE FROM ANOTHER SOURCE. COVERAGE PROVIDED UNDER THIS
- 7 SECTION ENDS FOR A NONSPOUSE DEPENDENT IF ANY OF THE FOLLOWING
- 8 OCCUR:
- 9 (A) THE DEPENDENT QUALIFIES FOR AND OBTAINS COMPARABLE HEALTH
- 10 INSURANCE FROM ANOTHER SOURCE.
- 11 (B) THE LATER OF THE DEPENDENT'S EIGHTEENTH BIRTHDAY OR, IF HE
- 12 OR SHE IS ENROLLED AS A FULL-TIME STUDENT IN HIGH SCHOOL OR AN
- 13 ACCREDITED UNIVERSITY OR COLLEGE, HIS OR HER TWENTY-SIXTH BIRTHDAY.
