by amending section 11a (MCL 207.561a), as added by 2012 PA 397.

Sec. 11a. (1) If a facility was subject to an industrial facilities exemption certificate on **OR AFTER** December 31, 2012, notwithstanding any other provision of this act to the contrary, that portion of the facility that is eligible manufacturing personal property shall remain subject to the industrial facilities tax and shall remain exempt from ad valorem property taxes as

provided in section 8 until that eligible manufacturing personal 1 2 property would otherwise be exempt from the collection of taxes under section 9m, 9n, or 9o of the general property tax act, 1893 3 4 PA 206, MCL 211.9m, 211.9n, and 211.9o. THE HOLDER OF AN INDUSTRIAL FACILITIES EXEMPTION CERTIFICATE THAT HAS BEEN EXTENDED UNDER THIS 5 6 SUBSECTION SHALL INDICATE THAT PORTION OF A FACILITY THAT IS ELIGIBLE MANUFACTURING PERSONAL PROPERTY BY FILING AN AFFIDAVIT 7 WITH THE ASSESSOR OF THE TOWNSHIP OR CITY IN WHICH THE ELIGIBLE 8 9 MANUFACTURING PERSONAL PROPERTY IS LOCATED NOT LATER THAN FEBRUARY 10 10 OF THE FIRST YEAR FOR WHICH THE INDUSTRIAL FACILITIES EXEMPTION 11 CERTIFICATE FOR THAT PORTION OF THE FACILITY THAT IS ELIGIBLE 12 MANUFACTURING PERSONAL PROPERTY HAS BEEN EXTENDED UNDER THIS 13 SUBSECTION. THE AFFIDAVIT SHALL BE IN A FORM PRESCRIBED BY THE 14 STATE TAX COMMISSION.

(2) As used in this subsection, "eligible manufacturing
personal property" means that term as defined in section 9m of the
general property tax act, 1893 PA 206, MCL 211.9m.
