HOUSE BILL No. 4022

January 12, 2017, Introduced by Rep. Kosowski and referred to the Committee on Appropriations.

A bill to amend 1971 PA 140, entitled "Glenn Steil state revenue sharing act of 1971," (MCL 141.901 to 141.921) by adding section 915.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 915. (1) FOR STATE FISCAL YEARS BEGINNING ON AND AFTER
- 2 THE 2016-2017 STATE FISCAL YEAR, THE DEPARTMENT OF TREASURY SHALL
- 3 IMPLEMENT AN INCENTIVE PROGRAM AND THE DEPARTMENT OF TREASURY SHALL
- USE THE PROGRAM TO DISTRIBUTE ADDITIONAL REVENUE SHARING PAYMENTS
 - TO CITIES, VILLAGES, TOWNSHIPS, AND COUNTIES AS PROVIDED UNDER
 - SUBSECTION (2).
- 7 (2) TO THE EXTENT THAT A CITY, VILLAGE, TOWNSHIP, OR COUNTY
- 8 RECEIVED A PAYMENT UNDER SECTION 952 OR 955, OR BOTH, OF ARTICLE
- 9 VIII OF 2015 PA 84, THAT CITY, VILLAGE, TOWNSHIP, OR COUNTY MAY

- 1 QUALIFY FOR AN ADDITIONAL PAYMENT OF UP TO AN AMOUNT EQUAL TO 20%
- 2 OF THE PAYMENT THAT CITY, VILLAGE, TOWNSHIP, OR COUNTY RECEIVED IN
- 3 THE IMMEDIATELY PRECEDING STATE FISCAL YEAR. A CITY, VILLAGE,
- 4 TOWNSHIP, OR COUNTY IS ELIGIBLE FOR AN INCREASED PAYMENT UNDER 1 OR
- 5 MORE OF THE FOLLOWING CATEGORIES AT THE FOLLOWING RATES AS FOLLOWS:

- 11 WITH OTHER JURISDICTIONS. A PLAN SHALL INCLUDE A LISTING OF ANY
- 12 PREVIOUS SERVICES CONSOLIDATED WITH THE COST SAVINGS REALIZED FROM
- 13 EACH CONSOLIDATION AND AN ESTIMATE OF THE POTENTIAL SAVINGS FOR ANY
- 14 NEW SERVICE CONSOLIDATIONS BEING PLANNED. A PLAN SHALL BE MADE
- 15 READILY AVAILABLE TO THE PUBLIC. EACH CITY, VILLAGE, TOWNSHIP, AND
- 16 COUNTY APPLYING FOR A PAYMENT UNDER THIS SUBDIVISION SHALL SUBMIT A
- 17 COPY OF THE COOPERATION, COLLABORATION, AND CONSOLIDATION PLAN TO
- 18 THE DEPARTMENT OF TREASURY.
- 19 (B) CATEGORY 2, WORKFORCE REDUCTION, 4.0% BONUS, REQUIRES EACH
- 20 CITY, VILLAGE, TOWNSHIP, OR COUNTY THAT HAS ENTERED A PLAN AS
- 21 PROVIDED UNDER SUBDIVISION (A) TO PROVIDE DOCUMENTATION TO THE
- 22 DEPARTMENT VERIFYING THAT PURSUANT TO THE PLAN THE CITY, VILLAGE,
- 23 TOWNSHIP, OR COUNTY HAS REDUCED ITS WORKFORCE BY AT LEAST 5.0% OR 3
- 24 EMPLOYEES, WHICHEVER IS MORE, SINCE JANUARY 1, 2012.
- 25 (C) CATEGORY 3, BUDGET REDUCTION, 4.0% BONUS, REQUIRES EACH
- 26 ELIGIBLE CITY, VILLAGE, TOWNSHIP, OR COUNTY TO CERTIFY THAT SINCE
- 27 JANUARY 1, 2012 THAT CITY, VILLAGE, TOWNSHIP, OR COUNTY HAS REDUCED

- 1 ITS OVERALL BUDGET BY AT LEAST 5.0%.
- 2 (D) CATEGORY 4, BALANCED BUDGET, 4.0%, REQUIRES EACH ELIGIBLE
- 3 CITY, VILLAGE, TOWNSHIP, OR COUNTY TO CERTIFY THAT SINCE JANUARY 1,
- 4 2012 THAT CITY, VILLAGE, TOWNSHIP, OR COUNTY HAS MAINTAINED A
- 5 BALANCED BUDGET FOR 2 CONSECUTIVE YEARS.
- 6 (3) PAYMENTS UNDER THIS SECTION ARE SUBJECT TO THE FOLLOWING
- 7 CONDITIONS:
- 8 (A) IN ORDER FOR A CITY, VILLAGE, TOWNSHIP, OR COUNTY TO
- 9 QUALIFY FOR A CATEGORY UNDER SUBSECTION (2), THE CITY, VILLAGE,

- 17 (2). THE DEPARTMENT SHALL DEVELOP A CERTIFICATION PROCESS AND

- 19 (B) FOR EACH CATEGORY THAT A CITY, VILLAGE, TOWNSHIP, OR
- 20 COUNTY QUALIFIES FOR IN SUBSECTION (2), THE CITY, VILLAGE,
- 21 TOWNSHIP, OR COUNTY SHALL RECEIVE ITS POTENTIAL INCENTIVE PROGRAM

- 4 PAYMENTS AND SHALL REPAY THIS STATE ALL INCENTIVE PROGRAM PAYMENTS
- 5 IT HAS RECEIVED.
- 6 (E) PAYMENTS UNDER THIS SECTION SHALL BE DISTRIBUTED ON THE
- 7 LAST BUSINESS DAY OF OCTOBER, DECEMBER, FEBRUARY, APRIL, JUNE, AND
- 8 AUGUST.
- 9 (4) EXCEPT AS OTHERWISE PROVIDED UNDER SECTIONS 17A AND 21, A
- 10 CITY, VILLAGE, TOWNSHIP, OR COUNTY THAT QUALIFIES FOR AN INCREASED
- 11 PAYMENT UNDER THIS SECTION SHALL CONTINUE TO RECEIVE THAT INCREASED
- 12 PAYMENT UNDER THIS SECTION EACH STATE FISCAL YEAR AND ADDITIONAL
- 13 VERIFICATION IS NOT REQUIRED TO QUALIFY FOR PAYMENTS IN SUBSEQUENT
- 14 FISCAL YEARS.
