## **HOUSE BILL NO. 5368**

A bill to amend 1965 PA 203, entitled "Michigan commission on law enforcement standards act," by amending section 2 (MCL 28.602), as amended by 2016 PA 289.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 8 (B) An individual employed as a Michigan tribal law
  9 enforcement officer by a federally recognized Indian tribe that has
  10 trust lands located within this state, subject to a written
  11 instrument authorizing the individual to enforce the laws of this
  12 state.
- 13 (C) The sergeant at arms or any assistant sergeant at arms of
  14 either house of the legislature who is commissioned as a police
  15 officer by that respective house of the legislature as provided by
  16 the legislative sergeant at arms police powers act, 2001 PA 185,
