HOUSE BILL NO. 5526

February 20, 2020, Introduced by Rep. Reilly and referred to the Committee on Health Policy.

A bill to amend 1979 PA 218, entitled "Adult foster care facility licensing act,"

by amending sections 5 and 34b (MCL 400.705 and 400.734b), section 5 as amended by 2018 PA 557 and section 34b as amended by 2018 PA 558.

- 1 Sec. 5. (1) "Good moral character" means good moral character
 2 as defined in 1974 PA 381, MCL 338.41 to 338.47.
- 3 (2) "Licensed hospice program" means a health care program





- 1 that provides a coordinated set of services rendered at home or in
- 2 an outpatient or institutional setting for individuals suffering
- 3 from a disease or condition with a terminal prognosis and that is
- 4 licensed under article 17 of the public health code, 1978 PA 368,
- **5** MCL 333.20101 to 333.22260.**333.21925.**
- 6 (3) "Licensee" means the agency, association, corporation,
- 7 organization, person, or department or agency of the state, county,
- 8 city, or other political subdivision, that has been issued a
- 9 license to operate an adult foster care facility.
- 10 (4) "Licensee designee" means the individual designated in
- 11 writing by the owner or person with legal authority to act on
- 12 behalf of the company or organization on licensing matters. The
- 13 licensee designee must meet the licensee qualification requirements
- 14 of this act and rules promulgated under this act. The licensee
- 15 designee who is not an owner, partner, or director of the applicant
- 16 shall not sign the original license application or amendments to
- 17 the application.
- 18 (5) "Mental illness" means a substantial disorder of thought
- 19 or mood that significantly impairs judgment, behavior, capacity to

 substantiated finding of neglect, abuse, or misappropriation of
 property by a state or federal agency according to an investigation
 conducted in accordance with 42 USC 1395i-3 or 1396r.
- (2) Except as otherwise provided in this subsection or subsection (6), an adult foster care facility shall not employ or independently contract with an individual who has direct access to residents until the adult foster care facility or staffing agency has conducted a criminal history check in compliance with this section or has received criminal history record information in



- 1 compliance with subsections (3) and (11). This subsection and
- 2 subsection (1) do not apply to an individual who is employed by or
- 3 under contract to an adult foster care facility before April 1,
- 4 2006. On or before April 1, 2011, an individual who is exempt under
- 5 this subsection and who has not been the subject of a criminal
- 6 history check conducted in compliance with this section shall
- 7 provide the department of state police a set of fingerprints and

- 27 shall give written consent at the time of application for the
- 28 department of state police to conduct a criminal history check
- 29 under this section, along with identification acceptable to the



department of state police. If the individual has been the subject 1 of a criminal history check conducted in compliance with this 2 section, the individual shall give written consent at the time of 3 application for the adult foster care facility or staffing agency 4 5 to obtain the criminal history record information as prescribed in 6 subsection (4) or (5) from the relevant licensing or regulatory 7 department and for the department of state police to conduct a 8 criminal history check under this section if the requirements of 9 subsection (11) are not met and a request to the Federal Bureau of 10 Investigation to make a determination of the existence of any 11 national criminal history pertaining to the individual is 12 necessary, along with identification acceptable to the department 13 of state police. Upon On receipt of the written consent to obtain 14 the criminal history record information and identification required 15 under this subsection, the adult foster care facility or staffing 16 agency that has made a good-faith offer of employment or an 17 independent contract to the individual shall request the criminal 18 history record information from the relevant licensing or 19 regulatory department and shall make a request regarding that 20 individual to the relevant licensing or regulatory department to conduct a check of all relevant registries in the manner required 21 in subsection (4). If the requirements of subsection (11) are not 22 23 met and a request to the Federal Bureau of Investigation to make a 24 subsequent determination of the existence of any national criminal 25 history pertaining to the individual is necessary, the adult foster 26 care facility or staffing agency shall proceed in the manner 27 required in subsection (5). A staffing agency that employs an individual who regularly has direct access to or provides direct 28 29 services to residents under an independent contract with an adult



1 foster care facility shall submit information regarding the
2 criminal history check conducted by the staffing agency to the
3 adult foster care facility that has made a good-faith offer of
4 independent contract to that applicant.

5 (4) Upon On receipt of the written consent to conduct a 6 criminal history check and identification required under subsection 7 (3), the adult foster care facility or staffing agency that has 8 made a good-faith offer of employment or independent contract to 9 the individual shall make a request to the department of state 10 police to conduct a criminal history check on the individual and 11 input the individual's fingerprints into the automated fingerprint identification system database, and shall make a request to the 12 relevant licensing or regulatory department to perform a check of 13 14 all relevant registries established according to federal and state 15 law and regulations for any substantiated findings of abuse, 16 neglect, or misappropriation of property. The request shall must be 17 made in a manner prescribed by the department of state police and 18 the relevant licensing or regulatory department or agency. The 19 adult foster care facility or staffing agency shall make the 20 written consent and identification available to the department of state police and the relevant licensing or regulatory department or 21 agency. Until June 30, 2020, if the department of state police or 22 23 the Federal Bureau of Investigation charges a fee for conducting the criminal history check, the charge shall be paid by or 24 25 reimbursed by the department. Until June 30, 2020, the adult foster care facility or staffing agency shall not seek reimbursement for a 26 27 charge imposed by the department of state police or the federal 28 bureau of investigation Federal Bureau of Investigation from the 29 individual who is the subject of the criminal history check.



- 1 Beginning July 1, 2020, if the department of state police or the
- 2 Federal Bureau of Investigation charges a fee for conducting the
- 3 criminal history check, the charge shall be paid by the adult
- 4 foster care facility, the staffing agency, or the individual. The
- 5 department of state police shall conduct a criminal history check
- 6 on the individual named in the request. The department of state
- 7 police shall provide the department with a written report of the
- 8 criminal history check conducted under this subsection. The report
- 9 shall must contain any criminal history record information on the
- 10 individual maintained by the department of state police.
- 11 (5) Upon—On receipt of the written consent to conduct a
- 12 criminal history check and identification required under subsection
- 13 (3), if the individual has applied for employment either as an
- 14 employee or as an independent contractor with an adult foster care
- 15 facility or staffing agency, the adult foster care facility or
- 16 staffing agency that has made a good-faith offer of employment or
- 17 independent contract shall comply with subsection (4) and shall
- 18 make a request to the department of state police to forward the
- 19 individual's fingerprints to the Federal Bureau of Investigation.
- 20 The department of state police shall request the Federal Bureau of
- 21 Investigation to make a determination of the existence of any
- 22 national criminal history pertaining to the individual. An
- 23 individual described in this subsection shall provide the
- 24 department of state police with a set of fingerprints. The
- 25 department of state police shall complete the criminal history
- 26 check under subsection (4) and, except as otherwise provided in
- 27 this subsection, provide the results of its determination under
- 28 subsection (4) and the results of the Federal Bureau of
- 29 Investigation determination to the department within 30 days after

- 16 (v) That he or she understands the conditions described in 17 subparagraphs (i) to (iv) that result in the termination of his or 18 her employment and that those conditions are good cause for 19 termination.
 - (c) Except as otherwise provided in this subdivision, the adult foster care facility does not permit the individual to have regular direct access to or provide direct services to residents in the adult foster care facility without supervision until the criminal history check or criminal history record information is obtained and the individual is eligible for that employment. If required under this subdivision, the adult foster care facility shall provide on-site supervision of an individual in the facility on a conditional basis under this subsection by an individual who has undergone a criminal history check conducted in compliance with

- 2 (11) Upon On consent of an individual as required in subsection (3) and upon on request from an adult foster care 3 facility or staffing agency that has made a good-faith offer of 4 5 employment or an independent contract to the individual, the 6 relevant licensing or regulatory department shall review the 7 criminal history record information, if any, and notify the 8 requesting adult foster care facility or staffing agency of the 9 information in the manner prescribed in subsection (4) or (5). 10 Until the Federal Bureau of Investigation implements an automatic 11 notification system similar to the system required of the state police under subsection (14) and federal regulations allow the 12 13 federal criminal record to be used for subsequent authorized uses, 14 as determined in an order issued by the department, an adult foster 15 care facility or staffing agency may rely on the criminal history 16 record information provided by the relevant licensing or regulatory department under this subsection and a request to the Federal 17 18 Bureau of Investigation to make a subsequent determination of the existence of any national criminal history pertaining to the 19 20 individual is not necessary if all of the following requirements 21 are met:

- 12 (g) "Mental health facility" means a psychiatric facility or
 13 other facility defined in 42 USC 1396d(d) as described under the

- (h) "Staffing agency" means an entity that recruits candidates and provides temporary and permanent qualified staffing for adult foster care facilities, including independent contractors.

- (i) (j) "Under the adult foster care facility's control" means
 an individual employed by or under independent contract with an
 adult foster care facility for whom the adult foster care facility

 - (i) Determines whether the individual who has access to residents may provide care, treatment, or other similar support service functions to residents served by the adult foster care facility.
 - (ii) Directs or oversees 1 or more of the following:
