## **SENATE BILL NO. 971**

March 17, 2022, Introduced by Senators VANDERWALL, HOLLIER, WOJNO, BIZON, BUMSTEAD, ZORN, HORN, WOZNIAK, DALEY, VICTORY, MACDONALD, LASATA, JOHNSON, RUNESTAD, OUTMAN, HUIZENGA, THEIS, STAMAS, ALEXANDER, GEISS, CHANG, HERTEL, BRINKS, MCCANN, POLEHANKI, SANTANA, MOSS, IRWIN and SCHMIDT and referred to the Committee on Families, Seniors, and Veterans.

A bill to provide for a military veterans cemetery; to create the veterans cemetery fund; to authorize the purchase of land; and to provide for the powers and duties of certain state governmental officers and entities.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. This act may be cited as the "veterans cemetery act".
- 2 Sec. 2. As used in this act:
- 3 (a) "Department" means the department of military and veterans
- 4 affairs.
- 5 (b) "Director" means the director of the department.
- 6 (c) "Fund" means the veterans cemetery fund created in section

- 2 Sec. 3. (1) The department may acquire and purchase land in a
- 3 county with a population of not less than 12,500 and not greater
- 4 than 13,500 that is suitable for a veterans cemetery or designate
- 5 land owned by this state under the jurisdiction of the department
- 6 in a county with a population of not less than 12,500 and not
- 7 greater than 13,500 as a veterans cemetery.
- 8 (2) The director shall apply for and accept all grants
- 9 available under 38 USC 2408.
- Sec. 5. (1) The veterans cemetery fund is created in the state
- 11 treasury.
- 12 (2) The treasurer shall deposit money and other assets from
- 13 any source in the fund. The state treasurer shall direct the
- 14 investment of money in the fund and credit interest and earnings
- 15 from the investments to the fund.
- 16 (3) The department is the administrator of the fund for audits
- 17 of the fund. Money in the fund at the close of the fiscal year does
- 18 not lapse to the general fund.

- 21 (a) For architectural design or engineering plans, or both,

- Sec. 7. (1) The director shall administer a veterans cemetery
  created under this act.
- 3 (2) The director shall comply with federal laws and4 regulations in administering a cemetery created under this act.
- Sec. 9. The legislature shall appropriate sufficient money toaccomplish the purpose of this act.
