A bill to amend 1973 PA 116, entitled

"An act to provide for the protection of children through the licensing and regulation of child care organizations; to provide for the establishment of standards of care for child care organizations; to prescribe powers and duties of certain departments of this state and adoption facilitators; to provide penalties; and to repeal acts and parts of acts,"

by amending section 5r (MCL 722.115r), as added by 2017 PA 256.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 5r. (1) An individual required to undergo a criminal
- 2 history check as described in section 5n is ineligible for that
