HOUSE BILL NO. 5175

June 29, 2021, Introduced by Reps. Shannon, Haadsma, Steckloff, Tyrone Carter and Aiyash and referred to the Committee on Tax Policy.

A bill to amend 1933 PA 167, entitled "General sales tax act,"

(MCL 205.51 to 205.78) by adding sections $4\,\mathrm{kk}$ and $19\,\mathrm{a}$.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 4kk. (1) Subject to subsection (2), the tax under this
- 2 act does not apply to the sale of any of the following items if the
- 3 sale is made between 12:01 a.m. and 11:59 p.m. on the third
- 4 Saturday of August each year:
- 5 (a) Clothing if the sales price of each individual item is not

- 1 greater than \$100.00.
- 2 (b) School supplies if the sales price of each individual item
- 3 is not greater than \$20.00.
- 4 (c) A computer sold for noncommercial home or personal use, if
- 5 the sales price, less any manufacturer's rebate, of each individual
- 6 computer is not greater than \$1,000.00.
- 7 (d) A school computer supply sold for noncommercial home or
- 8 personal use, if the sales price, less any manufacturer's rebate,
- 9 of each individual school computer supply is not greater than
- 10 \$500.00.
- 11 (2) The exemption in subsection (1) does not apply to any of
- 12 the following:
- 13 (a) Clothing accessories or equipment.
- 14 (b) Sport or recreational equipment.
- 15 (c) Protective equipment.
- 16 (d) Any item sold for use in a trade or business.
- 17 (e) Furniture.
- 18 (3) As used in this section:
- (a) "Clothing" means, except as otherwise provided in
- 20 subdivision (b), all human wearing apparel suitable for general
- 21 use, including, but not limited to, the following:
- 22 (i) Aprons, household and shop.
- 23 (ii) Athletic supporters.
- 24 (iii) Baby receiving blankets.
- 25 (iv) Bathing suits and caps.
- 26 (v) Beach capes and coats.
- 27 (vi) Belts and suspenders.

- 2 (i) Belt buckles sold separately.
- 3 (ii) Costume masks sold separately.
- 4 (iii) Patches and emblems sold separately.
- 5 (iv) Sewing equipment and supplies, including, but not limited
- 6 to, knitting needles, patterns, pins, scissors, sewing machines,
- 7 sewing needles, tape measures, and thimbles.

- 28 (2) A purchase of eligible property under a layaway sale

- 1 qualifies for a sales tax holiday exemption if either of the 2 following applies:
- (a) Final payment on a layaway order is made by, and theproperty is given to, the purchaser during the exemption period.
- 5 (b) The purchaser selects the property and the retailer 6 accepts the order for the item during the exemption period, for 7 immediate delivery upon full payment, even if delivery is made 8 after the exemption period.
- 9 (3) If the seller offers a discount on eliqible property, the 10 discount reduces the sales price of the property and the discounted 11 sales price determines whether the sales price is within a sales tax holiday price threshold. If a discount applies to the total 12 13 amount paid by a purchaser rather than to the sales price of a 14 particular item and the purchaser has purchased both eligible 15 property and taxable property, the seller must allocate the discount based on the total sales prices of the taxable property 16 17 compared to the total sales prices of all property sold in that 18 same transaction.
- 19 (4) A coupon that reduces the sales price is treated as a 20 discount under subsection (3) if the seller is not reimbursed for 21 the coupon amount by a third party.

- (5) Articles normally sold as a single unit must continue to be sold as a single unit during a sales tax holiday. Such articles must not be priced separately and sold as individual items in order to obtain a sales tax holiday exemption.
- (6) Eligible property that a customer purchases during the exemption period with the use of a rain check qualifies for the sales tax holiday exemption regardless of when the rain check was issued. Issuance of a rain check during the exemption period does

- not qualify eligible property for the sales tax holiday exemption
 if the property is actually purchased after the exemption period.
- 3 (7) All of the following provisions apply to an exchange made 4 in regard to a sales tax holiday:

- (a) If a customer purchases an item of eligible property during the exemption period, but later exchanges the item for a similar eligible item, even if a different size, different color, or different with respect to another feature, no additional tax is due even if the exchange is made after the exemption period.
 - (b) If a customer purchases an item of eligible property during the exemption period, but after the exemption period has ended, the customer returns the item and receives credit on the purchase of a different item, the appropriate sales tax is due on the sale of the newly purchased item.
 - (c) If a customer purchases an item of eligible property before the exemption period, but during the exemption period the customer returns the item and receives credit on the purchase of a different item of eligible property, no sales tax is due on the purchase of the new item if the new item is purchased during the exemption period.
 - (8) For purposes of determining a sales tax holiday price threshold, if all the property in a shipment qualifies as eligible property and the sales price for each item in the shipment is within the sales tax holiday price threshold, then the seller does not have to allocate the delivery, handling, or service charge to determine if the price threshold is exceeded and the shipment is considered a sale of eligible products. If the shipment includes eligible property and taxable property, including an eligible item with a sales price in excess of the price threshold, the seller

- 1 must allocate the delivery charge by using 1 of the following
- 2 methods and tax the delivery charge allocated to the taxable
- 3 property:
- 4 (a) A percentage based on the total sales prices of the
- 5 taxable property compared to the total sales prices of all property
- 6 in the shipment.
- 7 (b) A percentage based on the total weight of the taxable
- 8 property compared to the total weight of all property in the
- 9 shipment.
- 10 (9) For the purpose of a sales tax holiday, eligible property
- 11 qualifies for exemption if either of the following requirements is
- 12 met
- 13 (a) The item is both delivered to and paid for by the customer
- 14 during the exemption period.
- 15 (b) The customer orders and pays for the item and the seller
- 16 accepts the order during the exemption period for immediate
- 17 shipment, even if delivery is made after the exemption period. The
- 18 seller accepts an order when the seller has taken action to fill
- 19 the order for immediate shipment. Actions to fill an order include
- 20 placement of an "in date" stamp on a mail order or assignment of an
- 21 "order number" to a telephone order. An order is for immediate
- 22 shipment if the customer does not request delayed shipment. An
- 23 order is for immediate shipment notwithstanding that the shipment
- 24 may be delayed because of a backlog of orders or because stock is
- 25 currently unavailable to, or on back order by, the seller.
- 26 (10) For a 60-day period immediately after a sales tax holiday
- 27 exemption period, if a customer returns an item that would qualify
- 28 for the exemption, no credit for or refund of sales tax shall be
- 29 given unless the customer provides a receipt or invoice that shows

- 1 that sales tax was paid, or the seller has sufficient documentation
- 2 to show that sales tax was paid on the specific item. The 60-day
- 3 period under this subsection is set solely for the purpose of
- 4 designating a time period during which the customer must provide
- 5 documentation that shows that sales tax was paid on returned
- 6 merchandise. The 60-day period under this subsection does not
- 7 change a seller's policy on the time period during which the seller
- 8 will accept returns.
- 9 (11) The time zone of the seller's location determines the 10 authorized time period for a sales tax holiday when the purchaser
- 11 is located in one time zone and a seller is located in another.
- 12 (12) As used in this section:
- (a) "Eligible property" means an item of a type that qualifies
 for a sales tax holiday under this act.
- 15 (b) "Layaway sale" means a transaction in which property is
- 16 set aside for future delivery to a customer who makes a deposit,
- 17 agrees to pay the balance of the sales price over a period of time,
- 18 and, at the end of the payment period, receives the property. An
- 19 order is accepted for layaway by the seller when the seller removes
- 20 the property from normal inventory or clearly identifies the
- 21 property as sold to the purchaser.
- 22 (c) "Rain check" means the seller allows a customer to
- 23 purchase an item at a certain price at a later time because the
- 24 particular item was out of stock.
