A bill to prohibit employers from making employment decisions based on certain factors that are unrelated to employment; to prohibit certain inquiries; to prohibit retaliation; and to provide remedies.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 1. This act may be cited as the "employee family health
 privacy act".
- 3 Sec. 3. As used in this act:
- 4 (a) "Employee" means an individual who receives compensation

- 3 (b) "Employer" means an individual or entity that permits 1 or

- 6 Sec. 5. (1) Subject to subsection (2), an employer shall not
- 7 do either of the following:
- 8 (a) Discharge, fail or refuse to hire or recruit, or otherwise
- 9 discriminate against an individual with respect to employment,
- 10 compensation, or a term, condition, or privilege of employment
- 11 because of a known or believed illness or health condition of a
- 12 member of the individual's family.
- 13 (b) Inquire as to the physical condition or health status of a

- 15 (2) Subsection (1) does not prohibit an employer from making

- Sec. 9. An employer shall not require an individual to waive

- 1 any right under this act. An agreement by an individual to waive
- 2 any right under this act is invalid and unenforceable.
- 3 Sec. 11. (1) A person who is injured by a violation of this
- 4 act may bring a civil action to obtain injunctive relief and
- 5 damages.
- **6** (2) The court shall award costs and reasonable attorney fees
- 7 to a person who prevails as a plaintiff in an action authorized
- 8 under subsection (1).
- 9 Sec. 13. This act applies to a collective bargaining agreement
- 10 or employment agreement entered into, renewed, or extended on or
- 11 after the effective date of this act.
