## **HOUSE BILL NO. 5837**

February 23, 2022, Introduced by Rep. Weiss and referred to the Committee on Appropriations.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 ARTICLE I 2 STATE AID TO PUBLIC SCHOOLS, EARLY CHILDHOOD, AND ADULT EDUCATION 3 Sec. 3. (1) "Average daily attendance", for the purposes of complying with 4 federal law, means 92% of the pupils counted in membership on the pupil membership 5 count day, as defined in section 6(7). 6 (2) "Board" means the governing body of a district or public school academy. 7 (3) "Center" means the center for educational performance and information 8 created in section 94a. 9 (4) "Community district" means a school district organized under part 5b of the 10 revised school code. 11 (5) "Cooperative education program" means a written voluntary agreement between 12 and among districts to provide certain educational programs for pupils in certain 13 groups of districts. The written agreement must be approved by all affected districts 14 at least annually and must specify the educational programs to be provided and the 15 estimated number of pupils from each district who will participate in the educational 16 programs. 17 (6) "Department", except as otherwise provided in this article, means the 18 department of education. 19 (7) "District" means a local school district established under the revised 20 school code or, except in sections 6(4), 6(6), 11x, 11y, 13, 20, 22a, 22p, 31a, 21 51a(14), 105, 105c, and 166b, a public school academy. Except in section 20, district 22 also includes a community district. 23 (8) "District of residence", except as otherwise provided in this subsection, 24 means the district in which a pupil's custodial parent or parents or legal guardian

resides. For a pupil described in section 24b, the pupil's district of residence is

- 2 section 6(4)(d), the pupil's district of residence is considered to be the district or
- 3 intermediate district in which the pupil is counted in membership under that section.
- 4 For a pupil under court jurisdiction who is placed outside the district in which the
- 5 pupil's custodial parent or parents or legal quardian resides, the pupil's district of
- 6 residence is considered to be the educating district or educating intermediate
- 7 district.
- $oldsymbol{8}$  (9) "District superintendent" means the superintendent of a district or the
- 9 chief administrator of a public school academy.
- 10 Sec. 6. (1) "Center program" means a program operated by a district or by an
- 11 intermediate district for special education pupils from several districts in programs
- 12 for pupils with autism spectrum disorder, pupils with severe cognitive impairment,
- 13 pupils with moderate cognitive impairment, pupils with severe multiple impairments,
- 14 pupils with hearing impairment, pupils with visual impairment, and pupils with
- 15 physical impairment or other health impairment. Programs for pupils with emotional
- 16 impairment housed in buildings that do not serve regular education pupils also
- 17 qualify. Unless otherwise approved by the department, a center program either serves
- 18 all constituent districts within an intermediate district or serves several districts
- 19 with less than 50% of the pupils residing in the operating district. In addition,
- 20 special education center program pupils placed part-time in noncenter programs to
- 21 comply with the least restrictive environment provisions of section 1412 of the
- 22 individuals with disabilities education act, 20 USC 1412, may be considered center
- 23 program pupils for pupil accounting purposes for the time scheduled in either a center
- 24 program or a noncenter program.
- 25 (2) "District and high school graduation rate" means the annual completion and
- 26 pupil dropout rate that is calculated by the center pursuant to nationally recognized

(3) "District and high school graduation report" means a report of the number of pupils, excluding adult education participants, in the district for the immediately preceding school year, adjusted for those pupils who have transferred into or out of the district or high school, who leave high school with a diploma or other credential of equal status.

(4) "Membership", except as otherwise provided in this subsection or this article, means for a district, a public school academy, or an intermediate district the sum of the product of .90 times the number of full-time equated pupils in grades K to 12 actually enrolled and in regular daily attendance in the district, public school academy, or intermediate district on the pupil membership count day for the current school year, plus the product of .10 times the final audited count from the supplemental count day of full-time equated pupils in grades K to 12 actually enrolled and in regular daily attendance in the district, public school academy, or intermediate district for the immediately preceding school year. A district's, public school academy's, or intermediate district's membership is adjusted as provided under section 25e for pupils who enroll after the pupil membership count day in a strict discipline academy operating under sections 1311b to 1311m of the revised school code, MCL 380.1311b to 380.1311m. For 2021-2022 only, membership means for a district, a public school academy, or an intermediate district, the sum of the product of .90 times the number of full-time equated pupils in grades K to 12 actually enrolled and in regular daily attendance in the district, public school academy, or intermediate district on the pupil membership count day for the current school year and the product of .10 times the final audited count of the number of full-time equated pupils engaged in pandemic learning for spring 2021, or, for a public school academy that operates a cyber school, as that term is defined in section 551 of the revised school code, MCL

1 380.551, the final audited count from the supplemental count day of full-time equated 2 pupils in grades K to 12 actually enrolled and in regular daily attendance in the 3 public school academy for the immediately preceding school year. All pupil counts used 4 in this subsection are as determined by the department and calculated by adding the 5 number of pupils registered for attendance plus pupils received by transfer and minus 6 pupils lost as defined by rules promulgated by the superintendent, and as corrected by 7 a subsequent department audit. The amount of the foundation allowance for a pupil in 8 membership is determined under section 20. In making the calculation of membership, 9 all of the following, as applicable, apply to determining the membership of a 10 district, a public school academy, or an intermediate district: 11 (a) Except as otherwise provided in this subsection, and pursuant to subsection 12 (6), a pupil is counted in membership in the pupil's educating district or districts. 13 An individual pupil must not be counted for more than a total of 1.0 full-time equated 14 membership. 15 (b) If a pupil is educated in a district other than the pupil's district of 16 residence, if the pupil is not being educated as part of a cooperative education 17 program, if the pupil's district of residence does not give the educating district its 18 approval to count the pupil in membership in the educating district, and if the pupil 19 is not covered by an exception specified in subsection (6) to the requirement that the 20 educating district must have the approval of the pupil's district of residence to 21 count the pupil in membership, the pupil is not counted in membership in any district. 22 (c) A special education pupil educated by the intermediate district is counted

(d) A pupil placed by a court or state agency in an on-grounds program of a

juvenile detention facility, a child caring institution, or a mental health

institution, or a pupil funded under section 53a, is counted in membership in the

- 1 district or intermediate district approved by the department to operate the program.
- (e) A pupil enrolled in the Michigan Schools for the Deaf and Blind is countedin membership in the pupil's intermediate district of residence.
- 4 (f) A pupil enrolled in a career and technical education program supported by a
  5 millage levied over an area larger than a single district or in an area vocational6 technical education program established under section 690 of the revised school code,
  7 MCL 380.690, is counted in membership only in the pupil's district of residence.
- 8 (g) A pupil enrolled in a public school academy is counted in membership in the9 public school academy.

- (h) For the purposes of this section and section 6a, for a cyber school, as that term is defined in section 551 of the revised school code, MCL 380.551, that is in compliance with section 553a of the revised school code, MCL 380.553a, a pupil's participation in the cyber school's educational program is considered regular daily attendance, and for a district or public school academy, a pupil's participation in a virtual course as that term is defined in section 21f is considered regular daily attendance. For the purposes of this subdivision, for a pupil enrolled in a cyber school and utilizing sequential learning, participation means that term as defined in the pupil accounting manual, section 5-O-D: requirements for counting pupils in membership-subsection 10.
- (i) For a new district or public school academy beginning its operation after December 31, 1994, membership for the first 2 full or partial fiscal years of operation is determined as follows:
- (i) If operations begin before the pupil membership count day for the fiscal year, membership is the average number of full-time equated pupils in grades K to 12 actually enrolled and in regular daily attendance on the pupil membership count day for the current school year and on the supplemental count day for the current school

- 1 year, as determined by the department and calculated by adding the number of pupils
- 2 registered for attendance on the pupil membership count day plus pupils received by
- 3 transfer and minus pupils lost as defined by rules promulgated by the superintendent,
- 4 and as corrected by a subsequent department audit, plus the final audited count from
- 5 the supplemental count day for the current school year, and dividing that sum by 2.
- **6** (ii) If operations begin after the pupil membership count day for the fiscal year
- 7 and not later than the supplemental count day for the fiscal year, membership is the
- 8 final audited count of the number of full-time equated pupils in grades K to 12
- 9 actually enrolled and in regular daily attendance on the supplemental count day for
- 10 the current school year.
- 11 (j) If a district is the authorizing body for a public school academy, then, in
- 12 the first school year in which pupils are counted in membership on the pupil
- 13 membership count day in the public school academy, the determination of the district's
- 14 membership excludes from the district's pupil count for the immediately preceding
- 15 supplemental count day any pupils who are counted in the public school academy on that
- 16 first pupil membership count day who were also counted in the district on the
- 17 immediately preceding supplemental count day.
- (k) For an extended school year program approved by the superintendent, a pupil
- 19 enrolled, but not scheduled to be in regular daily attendance, on a pupil membership
- 20 count day, is counted in membership.
- (l) To be counted in membership, a pupil must meet the minimum age requirement
- 22 to be eligible to attend school under section 1147 of the revised school code, MCL
- 23 380.1147, or must be enrolled under subsection (3) of that section, and must be less
- 24 than 20 years of age on September 1 of the school year except as follows:
- (i) A special education pupil who is enrolled and receiving instruction in a
- 26 special education program or service approved by the department, who does not have a

- 1 high school diploma, and who is less than 26 years of age as of September 1 of the
- 2 current school year is counted in membership.
- 3 (ii) A pupil who is determined by the department to meet all of the following may
- 4 be counted in membership:
- 5 (A) Is enrolled in a public school academy or an alternative education high
- 6 school diploma program, that is primarily focused on educating pupils with extreme
- 7 barriers to education, such as being homeless as that term is defined under 42 USC
- **8** 11302.
- 9 (B) Had dropped out of school.
- 10 (C) Is less than 22 years of age as of September 1 of the current school year.
- 11 (iii) If a child does not meet the minimum age requirement to be eligible to
- 12 attend school for that school year under section 1147 of the revised school code, MCL
- 13 380.1147, but will be 5 years of age not later than December 1 of that school year,
- 14 the district may count the child in membership for that school year if the parent or
- 15 legal guardian has notified the district in writing that he or she intends to enroll
- 16 the child in kindergarten for that school year.
- 17 (m) An individual who has achieved a high school diploma is not counted in
- 18 membership. An individual who has achieved a high school equivalency certificate is
- 19 not counted in membership unless the individual is a student with a disability as that
- 20 term is defined in R 340.1702 of the Michigan Administrative Code. An individual
- 21 participating in a job training program funded under former section 107a or a jobs
- 22 program funded under former section 107b, administered by the department of labor and
- 23 economic opportunity, or participating in any successor of either of those 2 programs,
- 24 is not counted in membership.
- 25 (n) If a pupil counted in membership in a public school academy is also educated
- 26 by a district or intermediate district as part of a cooperative education program, the

- 1 pupil is counted in membership only in the public school academy unless a written
- 2 agreement signed by all parties designates the party or parties in which the pupil is
- 3 counted in membership, and the instructional time scheduled for the pupil in the
- 4 district or intermediate district is included in the full-time equated membership
- 5 determination under subdivision (q) and section 101. However, for pupils receiving
- 6 instruction in both a public school academy and in a district or intermediate district
- 7 but not as a part of a cooperative education program, the following apply:
- 8 (i) If the public school academy provides instruction for at least 1/2 of the
- 9 class hours required under section 101, the public school academy receives as its
- 10 prorated share of the full-time equated membership for each of those pupils an amount
- 11 equal to 1 times the product of the hours of instruction the public school academy
- 12 provides divided by the number of hours required under section 101 for full-time
- 13 equivalency, and the remainder of the full-time membership for each of those pupils is
- 14 allocated to the district or intermediate district providing the remainder of the
- 15 hours of instruction.
- 16 (ii) If the public school academy provides instruction for less than 1/2 of the
- 17 class hours required under section 101, the district or intermediate district
- 18 providing the remainder of the hours of instruction receives as its prorated share of
- 19 the full-time equated membership for each of those pupils an amount equal to 1 times
- 20 the product of the hours of instruction the district or intermediate district provides
- 21 divided by the number of hours required under section 101 for full-time equivalency,
- 22 and the remainder of the full-time membership for each of those pupils is allocated to
- 23 the public school academy.
- 24 (o) An individual less than 16 years of age as of September 1 of the current
- 25 school year who is being educated in an alternative education program is not counted
- 26 in membership if there are also adult education participants being educated in the

1 same program or classroom.

- 2 (p) The department shall give a uniform interpretation of full-time and part-3 time memberships.
- 4 (q) The number of class hours used to calculate full-time equated memberships 5 must be consistent with section 101. In determining full-time equated memberships for 6 pupils who are enrolled in a postsecondary institution or for pupils engaged in an 7 internship or work experience under section 1279h of the revised school code, MCL 8 380.1279h, a pupil is not considered to be less than a full-time equated pupil solely 9
- 10 internship or work experience, including necessary travel time, on the number of class 11 hours provided by the district to the pupil.

- (r) Full-time equated memberships for pupils in kindergarten are determined by dividing the number of instructional hours scheduled and provided per year per kindergarten pupil by the same number used for determining full-time equated memberships for pupils in grades 1 to 12. However, to the extent allowable under federal law, for a district or public school academy that provides evidence satisfactory to the department that it used federal title I money in the 2 immediately preceding school fiscal years to fund full-time kindergarten, full-time equated memberships for pupils in kindergarten are determined by dividing the number of class hours scheduled and provided per year per kindergarten pupil by a number equal to 1/2 the number used for determining full-time equated memberships for pupils in grades 1 to 12. The change in the counting of full-time equated memberships for pupils in kindergarten that took effect for 2012-2013 is not a mandate.
- (s) For a district or a public school academy that has pupils enrolled in a grade level that was not offered by the district or public school academy in the immediately preceding school year, the number of pupils enrolled in that grade level

- (v) If a pupil was enrolled in a public school academy on the pupil membership count day, if the public school academy's contract with its authorizing body is revoked or the public school academy otherwise ceases to operate, and if the pupil enrolls in a district within 45 days after the pupil membership count day, the department shall adjust the district's pupil count for the pupil membership count day to include the pupil in the count.
- (w) For a public school academy that has been in operation for at least 2 years and that suspended operations for at least 1 semester and is resuming operations, membership is the sum of the product of .90 times the number of full-time equated pupils in grades K to 12 actually enrolled and in regular daily attendance on the first pupil membership count day or supplemental count day, whichever is first, occurring after operations resume, plus the product of .10 times the final audited count from the most recent pupil membership count day or supplemental count day that occurred before suspending operations, as determined by the superintendent.
- (x) If a district's membership for a particular fiscal year, as otherwise calculated under this subsection, would be less than 1,550 pupils, the district has 4.5 or fewer pupils per square mile, as determined by the department, and the district does not receive funding under section 22d(2), the district's membership is considered to be the membership figure calculated under this subdivision. If a district educates and counts in its membership pupils in grades 9 to 12 who reside in a contiguous

- 1 district that does not operate grades 9 to 12 and if 1 or both of the affected
- 2 districts request the department to use the determination allowed under this sentence,
- 3 the department shall include the square mileage of both districts in determining the

- - (dd) For a pupil enrolled in a dropout recovery program that meets the requirements of section 23a, the pupil is counted as 1/12 of a full-time equated membership for each month that the district operating the program reports that the pupil was enrolled in the program and was in full attendance. However, if the special membership counting provisions under this subdivision and the operation of the other membership counting provisions under this subsection result in a pupil being counted as more than 1.0 FTE in a fiscal year, the payment made for the pupil under sections

- 1 22a and 22b must not be based on more than 1.0 FTE for that pupil, and any portion of
- 2 an FTE for that pupil that exceeds 1.0 is instead paid under section 25q. The district
- 3 operating the program shall report to the center the number of pupils who were

(1) From the state school aid fund money appropriated in section 11, there is allocated \$6,137,400.00 for 2021-2022-2022-2023 for assisting districts assigned by the superintendent to participate in a partnership and districts that have established a community engagement advisory committee in partnership with the department of treasury, are required to submit a deficit elimination plan or an enhanced deficit elimination plan under section 1220 of the revised school code, MCL 380.1220, and are located in a city with a population between 9,000 and 11,000, as determined by the department, that is in a county with a population between 150,000 and 160,000, as determined by the department, to improve student achievement and district financial stability. (2) The MiSTEM council annually shall review and make recommendations to the governor, the legislature, and the department concerning changes to the statewide strategy adopted by the council for delivering STEM education-related opportunities to pupils. The MiSTEM council shall use funds received under this subsection to ensure that its members or their designees are trained in the Change the Equation STEMworks rating system program for the purpose of rating STEM programs.
