These rules take effect immediately upon filing with the secretary of state unless adopted under section 33, 44, or 45a(6) of the administrative procedures act of 1969, 1969 PA 306, MCL 24.233, 24.244, or 24.245a. Rules adopted under these sections become effective 7 days after filing with the secretary of state.

(By authority conferred on the director of the department of licensing and regulatory affairs by sections **202 and section 205** of 1980 PA 299, **the occupational code, MCL 339.202 and 339.205**, and Executive Reorganization Order Nos. ~~4996-2~~ **1991-9**, 2003-1, 2008-4, and 2011-4, MCL ~~445.2001~~ **338.3501**, 445.2011, 445.2025, and 445.2030)

R 339.1002 and R 339.1003 of the Michigan Administrative Code are amended and R 339.1001a and R 339.1003a are added as follows:

PART 1. LICENSE AND REGISTRATION RENEWALS

**R 339.1001a Definitions.**

**Rule 1a. As used in these rules:**

- (a) **“Code” means the occupational code, 1980 PA 299, MCL 339.101 to 339.2677.**
- (b) **“Department” means the department of licensing and regulatory affairs.**
- (c) **“Issue date” means the date that the initial license was granted to the licensee by the department.**
- (d) **“Limitation” means a limitation relative to scope of practice as defined in MCL 339.105(3).**

R 339.1002 ~~Certain occupations; license and~~ **Annual** license renewal; expiration.

~~Rule 2. (1) License and license renewals that are issued for the collection practices board, private employment board, real estate board, cosmetology establishments and schools, and mortuary science trainees shall expire annually on the following dates and shall be renewed every year thereafter~~ **The following licenses expire annually and must be renewed each year on or before the date indicated:**

Collection practices.....	6/30.
<del>Private employment</del> <b>Personnel agencies.....</b>	<b>12/31.</b>
Real estate.....	10/31.
<del>Cosmetology establishments and schools.....</del>	<del>8/31.</del>

~~(2) Licenses and license renewals that are issued for barber apprentices and student instructors shall be valid for a period of 1 year from the date of issue and may be renewed on the same date thereafter.~~

R 339.1003 ~~Certain occupations, Biennial license or registration renewals~~ **renewal;** expiration.

Rule 3. (1) ~~Except as provided in R 339.1002 licenses or registrations and license or registration renewals that are issued for foresters, landscape architects, cosmetology, barbers, mortuary science, architects, professional surveyors, professional engineers, hearing aid dealers, accountancy, and real estate appraisers, and residential builders and maintenance and alteration contractors shall expire biennially on the following dates and shall be renewed every 2 years thereafter~~ **The following licenses and registrations expire biennially and must be renewed every 2 years on or before the date indicated:**

Landscape architects.....	7/31.
Real estate appraisers.....	7/31.
Cosmetology.....	8/31.
Barbers.....	9/30.
Mortuary science.....	10/31.
Architects.....	10/31.
Professional surveyors.....	10/31.
Professional engineers.....	10/31.
Hearing aid dealers.....	11/30.
Accountancy.....	7/31.
<b>Architects.....</b>	<b>10/31.</b>

(2) A license or registration that has a limitation may be renewed for a term that is less than ~~the biennial period~~ **2 years.**

(3) For licenses that are to be renewed biennially, the department may initially renew half of the licenses for 1 year and half of the licenses for 2 years to provide equal numbers of renewals in each fiscal year.

**R 339.1003a Triennial license renewal; expiration.**

**Rule 3a. (1) The following licenses expire triennially and must be renewed every 3 years on or before the date indicated:**

**(2) A license that has a limitation may be renewed for a term that is less than 3 years.**
