This rule becomes effective immediately upon filing with the secretary of state unless adopted under sections 33, 44, ~~or 45a(6), or 48~~ of **the administrative procedures act of 1969**, 1969 PA 306, **MCL 24.233, 24.244, or 24.245a**. Rules adopted under these sections become effective 7 days after filing with the secretary of state.

R 460.3308 of the Michigan Administrative Code is amended as follows:

PART 3. METER REQUIREMENTS

R 460.3308 Standards of good practice; adoption by reference.

Rule 308. In the absence of specific rules of the commission, a utility shall apply the provisions of the publications set forth in this rule as standards of accepted good practice.
