The Adult Foster Care Family Homes administrative rules provide for the licensing regulation of adult foster care family homes, including establishing the standard of quality care requirements. The current rule set will be rescinded and recodified into a single new rule set for licensing Adult Foster Care facilities that will comport with today's practice standards, harmonize them with current law and regulations, and to reflect the current organization of state licensing functions.
