Currently Executive Order 2020-154 is in effect to provide temporary authorization of remote participation in public meetings to mitigate the spread of COVID-19 by participating social-distancing measures and continues through October.

The amendments of the Ski Area Safety- General rule set are proposed to take effect immediately upon filing with the Secretary of State. The proposed rule set (2019-139 LR) is to update a reference to the American National Standards Institute (ANSI) standard B77.1 on safety requirements for passenger ropeways- aerial tramways, aerial lifts, surface lifts, tows and conveyors that is adopted by reference in this rule.




