The Nursing Home Administrators General Rules pertain to the licensure, relicensure, and license renewal for nursing home administrators.

The rules will be amended to provide clarity pertaining to education, training, testing requirements, licensing, continuing education, and telehealth services.

The proposed rules will add a telehealth rule; update accreditation standards; remove the minimum English language standard; clarify the requirements for relicensure and licensure by endorsement; and clarify rules pertaining to continuing education.
