3 MS. STINEDURF: Good afternoon. This is a public
4 hearing on new administrative rules being promulgated under
5 authority conferred on the Department of Attorney General by
6 section 5 of the Financial Exploitation Prevention Act, MCL
7 487.2085. This hearing is being conducted under the
8 provisions of the Administrative Procedures Act, MCL 24.201
9 to 24.328.

10 This hearing is being called to order at 1:00
11 p.m., on July 7th, 2021, at the offices of the Department of
12 Attorney General, Williams Building, in Lansing, Michigan.
