**3. Purpose for the proposed rules and background:**

The Professional Surveyors – General Rules pertain to definitions, education, experience, examination, licensure, relicensure, standards of conduct, the seal, license renewal, and continuing education for professional surveyors.

Amendment of the rules will take place to supply clarity on definitions, education, experience, examination, licensure, relicensure, standards of conduct, the seal, license renewal, and continuing education requirements for professional surveyors.

**4. Summary of proposed rules:**

The proposed rules will: clarify terms used in the rule set; clarify the requirement of proof of current and continuous licensure in another state or a province of Canada of at least four years to satisfy the experience requirement for licensure; clarify the requirements of the design and use of the seal of a professional surveyor; and clarify the period in which a licensee must request a waiver of continuing education.
