JCAR 21-36 (MOAHR No. 2020-084 TY) Department of Treasury, Charitable Gaming. These rules were submitted to JCAR on June 28, 2021. The last day for JCAR consideration is 15 session days from submission.

JCAR 21-37 (MOAHR No. 2020-060 EQ) Department of Environment, Great Lakes, and Energy, Air Pollution Control Part 9. Emission Limitation and Prohibitions - Miscellaneous. These rules were submitted to JCAR on July 20, 2021. The last day for JCAR consideration is 15 session days from submission.

JCAR 21-39 (MOAHR No. 2021-034 AG) Department of Attorney General, Financial Exploitation Prevention Act. These rules were originally submitted to JCAR as JCAR 21-38 on July 20, 2021, withdrawn on July 22, 2021, and resubmitted to JCAR as JCAR 21-39 on August 4, 2021. The last day for JCAR consideration is 15 session days from submission.

JCAR 21-41 (MOAHR No. 2020-024 LR) Department of Licensing and Regulatory Affairs, Podiatric Medicine and Surgery - General Rules. These rules were submitted to JCAR on August 10, 2021. The last day for JCAR consideration is 15 session days from submission.

JCAR 21-42 (MOAHR No. 2021-012 LR) Department of Licensing and Regulatory Affairs, Occupational Code Renewals. These rules were submitted to JCAR on August 10, 2021. The last day for JCAR consideration is 15 session days from submission.

JCAR 21-43 (MOAHR No. 2020-017 LR) Department of Licensing and Regulatory Affairs, Respiratory Care - General Rules. These rules were submitted to JCAR on August 10, 2021. The last day for JCAR consideration is 15 session days from submission.

JCAR 21-44 (MOAHR No. 2019-086 LR) Department of Licensing and Regulatory Affairs, Pharmacy - Animal Euthanasia and Sedation Rules. These rules were submitted to JCAR on August 17, 2021. The last day for JCAR consideration is 15 session days from submission.

JCAR 21-45 (MOAHR No. 2020-026 LE) Department of Labor and Economic Opportunity, Workers' Compensation Health Care Services. These rules were submitted to JCAR on August 26, 2021.

The last day for JCAR consideration is 15 session days from submission.

JCAR 21-46 (MOAHR No. 2019-021 LR) Department of Licensing and Regulatory Affairs, Firefighters Training Council - General Rules. These rules were submitted to JCAR on August 26, 2021. The last day for JCAR consideration is 15 session days from submission.

JCAR 21-47 (MOAHR No. 2019-129 LE) Department of Labor and Economic Opportunity, Workers' Disability Compensation Appeals Commission. These rules were submitted to JCAR on September 7, 2021. The last day for JCAR consideration is 15 session days from submission.

JCAR 21-48 (MOAHR No. 2020-068 LR) Department of Licensing and Regulatory Affairs, Barbers - General Rules. These rules were submitted to JCAR on September 10, 2021. The last day for JCAR consideration is 15 session days from submission.

JCAR 21-49 (MOAHR No. 2020-050 LR) Department of Licensing and Regulatory Affairs, Cosmetology - General Rules. These rules were submitted to JCAR on September 15, 2021. The last day for JCAR consideration is 15 session days from submission.

JCAR 21-50 (MOAHR No. 2019-137 LR) Department of Licensing and Regulatory Affairs, Preservation of Records of Electric, Gas, and Steam Utilities. These rules were submitted to JCAR on September 15, 2021. The last day for JCAR consideration is 15 session days from submission.

JCAR 21-51 (MOAHR No. 2019-130 LE) Department of Labor and Economic Opportunity, Workers' Compensation Board of Magistrates. These rules were submitted to JCAR on September 16, 2021. The last day for JCAR consideration is 15 session days from submission.

JCAR 21-52 (MOAHR No. 2020-112 LR) Department of Licensing and Regulatory Affairs, Behavior Analysts - General Rules. These rules were submitted to JCAR on October 4, 2021. The last day for JCAR consideration is 15 session days from submission.

JCAR 21-53 (MOAHR No. 2020-116 LR) Department of Licensing and Regulatory Affairs, Physician's Assistants - General Rules. These rules were submitted to JCAR on October 4, 2021. The last day for JCAR consideration is 15 session days from submission.

JCAR 21-54 (MOAHR No. 2020-127 LR) Department of Licensing and Regulatory Affairs, Psychology - General Rules. These rules were submitted to JCAR on October 4, 2021. The last day for JCAR consideration is 15 session days from submission.

JCAR 21-56 (MOAHR No. 2020-125 LR) Department of Licensing and Regulatory Affairs, Marriage and Family Therapy - General Rules. These rules were submitted to JCAR on October 11, 2021. The last day for JCAR consideration is 15 session days from submission.

JCAR 21-57 (MOAHR No. 2020-043 LR) Department of Licensing and Regulatory Affairs, Optometry - General Rules. These rules were submitted to JCAR on October 11, 2021. The last day for JCAR consideration is 15 session days from submission.

JCAR 21-58 (MOAHR No. 2021-030 LR) Department of Licensing and Regulatory Affairs, Veterinary Technician - General Rules. These rules were submitted to JCAR on October 11, 2021. The last day for JCAR consideration is 15 session days from submission.

JCAR 21-59 (MOAHR No. 2020-082 LR) Department of Licensing and Regulatory Affairs, Pharmacy - Controlled Substances. These rules were submitted to JCAR on October 11, 2021. The last day for JCAR consideration is 15 session days from submission.

How to Determine the Number of Session Days Left for JCAR Review of Rules**

Under MCL 24.245a, the Joint Committee on Administrative Rules generally has 15 session days to act on a set of rules submitted to the committee. To determine when that time will expire for a set of rules that you are interested in, do the following:

1. Determine the date the rules were submitted to JCAR.
2. Determine how many session days there have been since then. A session day is defined in MCL 24.245a(13) as a day in which both houses of the legislature convene and record a quorum. You can determine this yourself by checking the journals here:

If 15 session days have passed and JCAR has not taken up the rules, the rules are probably no longer before JCAR, and have

been or will soon be submitted to the Secretary of State and take effect.

Please note that under MCL 24.245a(12), a rule pending before the committee at the final adjournment of a regular session held in an even-numbered year must be withdrawn and resubmitted to the committee during the next session, at which point a new and untolled 15-session-day period begins.

Below is our list of days this session* on which both houses have convened and recorded a quorum. Please note that this is not an official list. We have done our best to prepare an accurate list, and we will attempt to update it regularly. If you see any mistakes, please let us know.
