JCAR 23-46 (MOAHR No. 2022-034 SP) Department of State Police, Forensic Science Division - Tests for Breath Alcohol. These rules were submitted to JCAR on March 27, 2023. The last day for JCAR consideration is 15 session days from submission.

JCAR 23-47 (MOAHR No. 2022-033 SP) Department of State Police, Forensic Science Division - Drunk Driving Equipment and Training Fund. These rules were submitted to JCAR on March 28, 2023. The last day for JCAR consideration is 15 session days from submission.

JCAR 23-49 (MOAHR No. 2022-049 LR) Department of Licensing and Regulatory Affairs, Bureau of Professional Licensing - Optometry - General Rules. These rules were submitted to JCAR on April 5, 2023. The last day for JCAR consideration is 15 session days from submission.

JCAR 23-50 (MOAHR No. 2021-093 LR) Department of Licensing and Regulatory Affairs, Bureau of Professional Licensing - Central Fill Pharmacies. These rules were submitted to JCAR on April 5, 2023. The last day for JCAR consideration is 15 session days from submission.

JCAR 23-51 (MOAHR No. 2022-020 HS) Department of Health and Human Services, Public Health Administration - EMS Life Support Agencies and Medical Control. These rules were submitted to JCAR on April 5, 2023. The last day for JCAR consideration is 15 session days from submission.

JCAR 23-52 (MOAHR No. 2022-039 EQ) Department of Environment, Great Lakes, and Energy, Drinking Water and Environmental Health Division - Groundwater Quality Control - Part. 1. Well Construction Code. These rules were submitted to JCAR on April 17, 2023. The last day for JCAR consideration is 15 session days from submission.

JCAR 23-53 (MOAHR No. 2022-045 LR) Department of Licensing and Regulatory Affairs, Bureau of Community and Health Systems - Adult Foster Care Family Homes. These rules were submitted to JCAR on April 21, 2023. The last day for JCAR consideration is 15 session days from submission.

JCAR 23-54 (MOAHR No. 2022-046 LR) Department of Licensing and Regulatory Affairs, Bureau of Community and Health Systems - Adult Foster Care Congregate Care Facilities. These rules were submitted to JCAR on April 21, 2023. The last day for JCAR consideration is 15 session days from submission.

JCAR 23-55 (MOAHR No. 2022-052 NR) Department of Natural Resources, Executive Division - Mackinac Island State Park Commission - General Rules. These rules were submitted to JCAR on April 21, 2023. The last day for JCAR consideration is 15 session days from submission.

JCAR 23-56 (MOAHR No. 2022-047 LR) Department of Licensing and Regulatory Affairs, Bureau of Community and Health Systems - Adult Foster Care Small Group Homes. These rules were submitted to JCAR on April 21, 2023. The last day for JCAR consideration is 15 session days from submission.

JCAR 23-57 (MOAHR No. 2022-014 LR) Department of Licensing and Regulatory Affairs, Bureau of Professional Licensing - Psychology - General Rules. These rules were submitted to JCAR on April 21, 2023. The last day for JCAR consideration is 15 session days from submission.

JCAR 23-58 (MOAHR No. 2020-003 HS) Department of Health and Human Services, Children's Services Agency - Foster Family Homes and Foster Family Group Homes. These rules were submitted to JCAR on April 25, 2023. The last day for JCAR consideration is 15 session days from submission.

JCAR 23-59 (MOAHR No. 2022-048 LR) Department of Licensing and Regulatory Affairs, Bureau of Community and Health Systems - Adult Foster Care Large Group Homes. These rules were submitted to JCAR on April 25, 2023. The last day for JCAR consideration is 15 session days from submission.

JCAR 23-60 (MOAHR No. 2020-002 HS) Department of Health and Human Services, Children's Services Agency - Child Placing Agencies. These rules were submitted to JCAR on May 2, 2023. The last day for JCAR consideration is 15 session days from submission.

JCAR 23-61 (MOAHR No. 2021-051 LR) Department of Licensing and Regulatory Affairs, Bureau of Professional Licensing - Pharmacy - Pharmacist Continuing Education. These rules were submitted to JCAR on May 3, 2023. The last day for JCAR consideration is 15 session days from submission.

JCAR 23-62 (MOAHR No. 2021-090 LR) Department of Licensing and Regulatory Affairs, Bureau of Community and Healthy Systems - Substance Use Disorder Service Programs. These rules were submitted to JCAR on May 4, 2023. The last day for JCAR consideration is 15 session days from submission.

How to Determine the Number of Session Days Left for JCAR Review of Rules**

Under MCL 24.245a, the Joint Committee on Administrative Rules generally has 15 session days to act on a set of rules submitted to the committee. To determine when that time will expire for a set of rules that you are interested in, do the following:

1. Determine the date the rules were submitted to JCAR.
2. Determine how many session days there have been since then. A session day is defined in MCL 24.245a(13) as a day in which both houses of the legislature convene and record a quorum. You can determine this yourself by checking the journals here:

If 15 session days have passed and JCAR has not taken up the rules, the rules are probably no longer before JCAR, and have been or will soon be submitted to the Secretary of State and take effect.

Please note that under MCL 24.245a(12), a rule pending before the committee at the final adjournment of a regular session held in an even-numbered year must be withdrawn and resubmitted to the committee during the next session, at which point a new and untolled 15-session-day period begins.

Below is our list of days this session* on which both houses have convened and recorded a quorum. Please note that this is not an official list. We have done our best to prepare an accurate list, and we will attempt to update it regularly. If you see any mistakes, please let us know.
