JCAR 24-13 (MOAHR No. 2022-057 LR) Department of Licensing and Regulatory Affairs, Bureau of Construction Codes - Construction Code - Part 4. Building Code. These rules were submitted to JCAR on May 21, 2024. The last day for JCAR consideration is 15 session days from submission.

JCAR 24-14 (MOAHR No. 2022-058 LR) Department of Licensing and Regulatory Affairs, Bureau of Construction Codes - Rehabilitation Code. These rules were submitted to JCAR on May 21, 2024. The last day for JCAR consideration is 15 session days from submission.

JCAR 24-15 (MOAHR No. 2023-037 LR) Department of Licensing and Regulatory Affairs, Bureau of Professional Licensing - Audiology - General Rules. These rules were submitted to JCAR on May 28, 2024. The last day for JCAR consideration is 15 session days from submission.

JCAR 24-16 (MOAHR No. 2021-049 LR) Department of Licensing and Regulatory Affairs, Bureau of Construction Codes, Construction Code - Part 10a. Michigan Energy Code. These rules were submitted to JCAR on June 4, 2024. The last day for JCAR consideration is 15 session days from submission.

JCAR 24-17 (MOAHR No. 2023-040 LR) Department of Licensing and Regulatory Affairs, Corporations, Securities, and Commercial Licensing - Securities. These rules were submitted to JCAR on June 11, 2024. The last day for JCAR consideration is 15 session days from submission.

JCAR 24-20 (MOAHR No. 2023-064 IF) Department of Insurance and Financial Services, Insurance - Term and Universal Life Insurance Reserve Financing. These rules were submitted to JCAR on June 20, 2024. The last day for JCAR consideration is 15 session days from submission.

JCAR 24-21 (MOAHR No. 2023-041 HS) Department of Health and Human Services, Economic Stability Administration - Food Assistance Program. These rules were submitted to JCAR on June 21, 2024. The last day for JCAR consideration is 15 session days from submission.

JCAR 24-22 (MOAHR No. 2023-047 LR) Department of Licensing and Regulatory Affairs, Bureau of Professional Licensing - Architects - General Rules. These rules were submitted to JCAR on June 25, 2024. The last day for JCAR consideration is 15 session days from submission.

JCAR 24-23 (MOAHR No. 2023-049 LR) Department of Licensing and Regulatory Affairs, Bureau of Professional Licensing - Professional Surveyors - General Rules. These rules were submitted to JCAR on June 25, 2024. The last day for JCAR consideration is 15 session days from submission.

JCAR 24-24 (MOAHR No. 2023-032 LR) Department of Licensing and Regulatory Affairs, Bureau of Professional Licensing - Real Estate Appraisers - General Rules. These rules were submitted to JCAR on July 3, 2024. The last day for JCAR consideration is 15 session days from submission.

JCAR 24-25 (MOAHR No. 2022-067 LR) Department of Licensing and Regulatory Affairs, Bureau of Professional Licensing - Nursing Home Administrators - General Rules. These rules were submitted to JCAR on July 3, 2024. The last day for JCAR consideration is 15 session days from submission.

JCAR 24-26 (MOAHR No. 2022-016 LR) Department of Licensing and Regulatory Affairs, Bureau of Construction Codes - Construction Code - Part 5. Residential Code. These rules were submitted to JCAR on July 9, 2024. The last day for JCAR consideration is 15 session days from submission.

JCAR 24-27 (MOAHR No. 2021-048 LR) Department of Licensing and Regulatory Affairs, Bureau of Construction Codes - Construction Code - Part 10. Michigan Uniform Energy Code. These rules were submitted to JCAR on July 15, 2024. The last day for JCAR consideration is 15 session days from submission.

JCAR 24-28 (MOAHR No. 2024-008 HS) Department of Health and Human Services, Public Health Administration - Amendments to Vital Records. These rules were submitted to JCAR on July 25, 2024. The last day for JCAR consideration is 15 session days from submission.

JCAR 24-29 (MOAHR No. 2024-009 HS) Department of Health and Human Services, Public Health Administration - Completion, Filing, and Registration of Vital Records Documents. These rules were submitted to JCAR on July 25, 2024. The last day for JCAR consideration is 15 session days from submission.

JCAR 24-30 (MOAHR No. 2024-004 TY) Department of Treasury, Michigan Gaming Control Board – Internet Gaming Rules. These rules were submitted to JCAR on July 25, 2024. The last day for JCAR consideration is 15 session days from submission.

JCAR 24-31 (MOAHR No. 2024-005 TY) Department of Treasury, Michigan Gaming Control Board – Internet Sports Betting Rules. These rules were submitted to JCAR on July 25, 2024. The last day for JCAR consideration is 15 session days from submission.

JCAR 24-32 (MOAHR No. 2024-018 ST) Department of State, Board of State Canvassers – Conduct of Election Recounts. These rules were submitted to JCAR on July 31, 2024. The last day for JCAR consideration is 15 session days from submission.

JCAR 24-33 (MOAHR No. 2023-011 EQ) Department of Environment, Great Lakes, and Energy, Air Quality Division – Air Pollution Control. Part 1. General Rules. These rules were submitted to JCAR on July 31, 2024. The last day for JCAR consideration is 15 session days from submission.

JCAR 24-34 (MOAHR No. 2023-014 EQ) Department of Environment, Great Lakes, and Energy, Air Quality Division – Air Pollution Control. Part 9. Emission Limitations and Prohibitions – Miscellaneous. These rules were submitted to JCAR on August 6, 2024. The last day for JCAR consideration is 15 session days from submission.

JCAR 24-35 (MOAHR No. 2023-048 LR) Department of Licensing and Regulatory Affairs, Bureau of Professional Licensing – Professional Engineers – General Rules. These rules were submitted to JCAR on August 27, 2024. The last day for JCAR consideration is 15 session days from submission.

JCAR 24-36 (MOAHR No. 2024-033 AG) Department of Attorney General, Financial Crimes Division – Uniform Securities Act (2002) Mandatory Reporting of Financial Exploitation. These rules were submitted to JCAR on August 27, 2024. The last day for JCAR consideration is 15 session days from submission.

JCAR 24-37 (MOAHR No. 2023-055 ST) Department of State, Bureau of Branch Office Services – Visual Standards for Motor Vehicle Drivers' Licenses. These rules were submitted to JCAR on September 10, 2024. The last day for JCAR consideration is 15 session days from submission.

JCAR 24-38 (MOAHR No. 2023-073 LR) Department of Licensing and Regulatory Affairs, Bureau of Professional Licensing – Optometry – General Rules. These rules were submitted to JCAR on September 11, 2024. The last day for JCAR consideration is 15 session days from submission.

JCAR 24-39 (MOAHR No. 2024-019 ST) Department of State, Bureau of Elections – Electronic Voting Systems. These rules were submitted to JCAR on September 11, 2024. The last day for JCAR consideration is 15 session days from submission.

JCAR 24-40 (MOAHR No. 2023-035 LR) Department of Licensing and Regulatory Affairs, Bureau of Professional Licensing – Chiropractic – General Rules. These rules were submitted to JCAR on September 18, 2024. The last day for JCAR consideration is 15 session days from submission.

How to Determine the Number of Session Days Left for JCAR Review of Rules**

Under MCL 24.245a, the Joint Committee on Administrative Rules generally has 15 session days to act on a set of rules submitted to the committee. To determine when that time will expire for a set of rules that you are interested in, do the following:

1. Determine the date the rules were submitted to JCAR.
2. Determine how many session days there have been since then. A session day is defined in MCL 24.245a(13) as a day in which both houses of the legislature convene and record a quorum. You can determine this yourself by checking the journals here:

If 15 session days have passed and JCAR has not taken up the rules, the rules are probably no longer before JCAR, and have been or will soon be submitted to the Secretary of State and take effect.

Please note that under MCL 24.245a(12), a rule pending before the committee at the final adjournment of a regular session held in an even-numbered year must be withdrawn and resubmitted to the committee during the next session, at which point a new and untolled 15-session-day period begins.

Below is our list of days this session* on which both houses have convened and recorded a quorum. Please note that this is not an official list. We have done our best to prepare an accurate list, and we will attempt to update it regularly. If you see any mistakes, please let us know.
