JCAR 25-01 (MOAHR No. 2024-033 AG) Department of Attorney General, Financial Crimes Division - Uniform Securities Act (2002). These rules were submitted to JCAR on January 30, 2025. The last day for JCAR consideration is 15 session days from submission.

JCAR 25-02 (MOAHR No. 2023-005 EQ) Department of Environment, Great Lakes, and Energy, Materials Management Division - Hazardous Waste Management. These rules were submitted to JCAR on January 30, 2025. The last day for JCAR consideration is 15 session days from submission.

JCAR 25-03 (MOAHR No. 2023-011 EQ) Department of Environment, Great Lakes, and Energy, Air Quality Division - Part 1. General Provisions. These rules were submitted to JCAR on January 30, 2025. The last day for JCAR consideration is 15 session days from submission.

These rules were submitted to JCAR on February 4, 2025. The last day for JCAR consideration is 15 session days from submission.

JCAR 25-36 (MOAHR No. 2022-013 HS) Department of Health and Human Services, Public Health Administration - Amyotrophic Lateral Sclerosis (ALS) Reporting. These rules were submitted to JCAR on February 24, 2025. The last day for JCAR consideration is 15 session days from submission.

JCAR 25-37 (MOAHR No. 2024-016 HS) Department of Health and Human Services, Children's Services Agency - Child Care Fund. These rules were submitted to JCAR on March 4, 2025. The last day for JCAR consideration is 15 session days from submission.

JCAR 25-38 (MOAHR No. 2023-059 HS) Department of Health and Human Services, Public Health Administration - Body Art Facilities. These rules were submitted to JCAR on March 13, 2025. The last day for JCAR consideration is 15 session days from submission.

JCAR 25-39 (MOAHR No. 2024-048 ST) Department of State, Bureau of Elections - Gifts under the Lobby Act. These rules were submitted to JCAR on March 24, 2025. The last day for JCAR consideration is 15 session days from submission.

JCAR 25-40 (MOAHR No. 2024-063 ST) Department of State, Bureau of Elections - Disqualification from Ballot Based Upon Contents of Affidavit of Identity. These rules were submitted to JCAR on March 24, 2025. The last day for JCAR consideration is 15 session days from submission.

JCAR 25-41 (MOAHR No. 2024-022 LE) Department of Labor and Economic Opportunity, Workers' Disability Compensation Agency - Workers' Compensation Health Care Services. These rules were submitted to JCAR on March 24, 2025. The last day for JCAR consideration is 15 session days from submission.

JCAR 25-42 (MOAHR No. 2023-075 LR) Department of Licensing and Regulatory Affairs, Bureau of Professional Licensing - Real Estate Brokers and Salespersons - General Rules. These rules were submitted to JCAR on April 3, 2025. The last day for JCAR consideration is 15 session days from submission.

How to Determine the Number of Session Days Left for JCAR Review of Rules**

Under MCL 24.245a, the Joint Committee on Administrative Rules generally has 15 session days to act on a set of rules submitted to the committee. To determine when that time will expire for a set of rules that you are interested in, do the following:

1. Determine the date the rules were submitted to JCAR.
2. Determine how many session days there have been since then. A session day is defined in MCL 24.245a(13) as a day in which both houses of the legislature convene and record a quorum. You can determine this yourself by checking the journals here:

If 15 session days have passed and JCAR has not taken up the rules, the rules are probably no longer before JCAR, and have been or will soon be submitted to the Secretary of State and take effect.

Please note that under MCL 24.245a(12), a rule pending before the committee at the final adjournment of a regular session held in an even-numbered year must be withdrawn and resubmitted to the committee during the next session, at which point a new and untolled 15-session-day period begins.
