

SUBSTITUTE FOR  
HOUSE BILL NO. 5605

A bill to amend 1976 PA 451, entitled  
"The revised school code,"  
(MCL 380.1 to 380.1852) by adding section 1538e.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1           **SEC. 1538E. (1) THE SUPERINTENDENT OF PUBLIC INSTRUCTION SHALL**  
2 **NOT APPROVE A TEACHER PREPARATION INSTITUTION UNDER SECTION 1538A**  
3 **AND R 390.1151 TO R 390.1153 OF THE MICHIGAN ADMINISTRATIVE CODE**  
4 **UNLESS THE TEACHER PREPARATION INSTITUTION OFFERS A TEACHER**  
5 **PREPARATION PROGRAM TO ITS STUDENTS THAT EMBEDS AT LEAST ALL OF THE**  
6 **FOLLOWING IN COURSEWORK:**  
7           **(A) THE USE OF DATA AND STATISTICS TO INFORM INSTRUCTION AND**  
8 **TO AGGREGATE LOCAL AND STATE ASSESSMENT DATA.**  
9           **(B) DEVELOPMENT OF CLASSROOM MANAGEMENT SKILLS.**  
10           **(C) TEACHING PUPILS FROM RURAL AND URBAN AREAS.**

1 (D) INSTRUCTION ON SOCIAL AND EMOTIONAL LEARNING PRACTICES.

2 (E) TEACHING PUPILS WHO ARE ENGLISH LANGUAGE LEARNERS.

3 (F) TEACHING PUPILS WITH A DISABILITY.

4 (G) TEACHING PUPILS FROM A HIGH-POVERTY AREA.

5 (2) BEGINNING JULY 1, [2021], IF THE SUPERINTENDENT OF PUBLIC  
6 INSTRUCTION APPROVED A TEACHER PREPARATION INSTITUTION UNDER  
7 SECTION 1538A AND R 390.1151 TO 390.1153 OF THE MICHIGAN  
8 ADMINISTRATIVE CODE BEFORE THE EFFECTIVE DATE OF THIS SECTION AND  
9 THE TEACHER PREPARATION INSTITUTION DID NOT MEET THE REQUIREMENTS  
10 UNDER THIS SECTION AT THE TIME THE APPROVAL WAS ISSUED, THE  
11 SUPERINTENDENT OF PUBLIC INSTRUCTION SHALL REVOKE THE APPROVAL. IF  
12 THE SUPERINTENDENT OF PUBLIC INSTRUCTION REVOKES AN APPROVAL UNDER  
13 THIS SUBSECTION, THE TEACHER PREPARATION INSTITUTION MAY REAPPLY  
14 FOR APPROVAL, IN A FORM AND MANNER PRESCRIBED BY THE SUPERINTENDENT  
15 OF PUBLIC INSTRUCTION.

16 Enacting section 1. This amendatory act takes effect 90 days  
17 after the date it is enacted into law.
