## **HOUSE BILL No. 6212**

June 12, 2018, Introduced by Reps. Calley, Lauwers, Victory, Vaupel, Alexander, Howell and Wentworth and referred to the Committee on Agriculture.

A bill to amend 1994 PA 358, entitled

"An act to regulate the possession of ferrets; to provide for the licensing of ferrets; to provide for requirements for importation and rabies control procedures for ferrets; to provide for the powers and duties of certain governmental entities; to prescribe penalties and provide remedies; and to repeal acts and parts of acts,"

by amending section 1 (MCL 287.891).

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. (1) "Accredited veterinarian" means a veterinarian
  - approved by the United States department of agriculture DEPARTMENT
    - OF AGRICULTURE to perform specific functions required by
    - cooperative state and federal disease control and eradication
- 5 programs.
  - (2) "Animal" means an animal other than a human being.

- 1 (3) "Animal control officer" means an individual employed as
- 2 an animal control officer pursuant to UNDER sections 29a, 29b, and
- 3 29c of the dog law of 1919, Act No. 339 of the Public Acts of 1919,
- 4 being sections 287.289a, 287.289b, and 287.289c of the Michigan
- 5 Compiled Laws.1919 PA 339, MCL 287.289A, 287.289B, AND 287.289C.
- 6 (4) "Approved vaccine" means a vaccine authorized by the state
- 7 veterinarian pursuant to UNDER the animal industry act, of 1987,
- 8 Act No. 466 of the Public Acts of 1988, being sections 287.701 to
- 9 287.747 of the Michigan Compiled Laws.1988 PA 466, MCL 287.701 TO
- 10 287.745.
- 11 (5) "Breeder" means a person who is a dealer as defined in the
- 12 animal welfare act, Public Law 89-544, 7 U.S.C. USC 2131 to 2147,
- 13 2149, and 2151 to 2159, and who is regulated by the United States
- 14 department of agriculture DEPARTMENT OF AGRICULTURE as a class A
- 15 licensee, breeder, or a class B licensee meeting the definition
- 16 of dealer in \$1.1, pursuant to title 9, C.F.R., subchapter A, part
- 17 1, section 1.1 and subpart F, sections 3.125 through 3.142.9 CFR
- 18 1.1 AND WHO IS REGULATED BY THE UNITED STATES DEPARTMENT OF
- 19 AGRICULTURE UNDER 9 CFR PART 3.
- 20 (6) "Department" means the department of agriculture AND RURAL
- 21 DEVELOPMENT.
- (7) "Director" means the director of the department  $\frac{1}{2}$
- 23 agriculture or his or her authorized representative.
- 24 (8) "Ferret" means an animal of any age of the species Mustela
- **25** furo.
- 26 (9) "Hobby breeder" means a person who owns 4 or fewer ferrets
- 27 that are at least 6 months of age or a litter of ferrets that is

- 1 less than 5 months of age on a temporary basis for personal
- 2 recreational purposes such as INCLUDING, BUT NOT LIMITED TO,
- 3 competitions in shows or improving the breed, and who registers his
- 4 or her ferrets with a national ferret registry organization.
- 5 (10) "Law enforcement agent" means an officer of the
- 6 department of state police, a law enforcement agency of a county,
- 7 township, city, or village who is responsible for the prevention
- 8 and detection of crime and enforcement of the criminal laws of this
- 9 state, or a conservation officer.
- 10 (11) "Local unit of government" means a county, city, village,
- 11 or township.
- 12 (12) "Official interstate health certificate" or "official
- 13 certificate of veterinary inspection" means a printed form that is
- 14 adopted by any state that documents the information described in
- 15 this subsection and that is issued by an accredited veterinarian
- 16 for animals being imported or exported from this state within 30
- 17 days before the importation or exportation of the animals it
- 18 describes. A photocopy of an official interstate health certificate
- 19 or official certificate of veterinary inspection is not valid. An
- 20 official interstate health certificate or official certificate of
- 21 veterinary inspection shall include all of the following:
- 22 (a) The complete names and addresses of the consignor and
- 23 consignee and the destination address if different from the
- 24 consignee address.
- 25 (b) A description of the ferret by breed, sex, age, color,
- 26 markings, and other identification.
- (c) The date of examination of the ferret by the accredited

- 1 veterinarian preparing the certificate.
- 2 (d) The health status of the ferret by recording the results
- 3 of any required tests and required vaccinations. The accredited
- 4 veterinarian preparing the certificate shall certify that the
- 5 ferret is free from clinical signs of infectious, contagious, or
- 6 toxicological diseases.
- 7 (13) "Owner" means a person having a right of property
- 8 ownership in a ferret, who keeps or harbors the ferret or has the
- 9 ferret in his or her care or custody, or who permits the ferret to
- 10 remain on or about premises occupied by the person. An owner does
- 11 not include a veterinarian who keeps a ferret on a temporary basis
- 12 for medical care or treatment.
- 13 (14) "Person" means an individual, partnership, corporation,
- 14 association, governmental entity, or other legal entity.
- 15 (15) "State veterinarian" means the chief animal health
- 16 official of the state as appointed by the director under section 7
- 17 of the animal industry act, of 1987, Act No. 466 of the Public Acts
- 18 of 1988, being section 287.707 of the Michigan Compiled Laws.1988
- 19 PA 466, MCL 287.707.
- 20 (16) "Veterinarian" means a person licensed to practice
- 21 veterinary medicine under article 15 of the public health code, Act
- 22 No. 368 of the Public Acts of 1978, being sections 333.16101 to
- 23 333.18838 of the Michigan Compiled Laws, 1978 PA 368, MCL 333.16101
- 24 TO 333.18838, or under the law of another state or federal
- 25 authority that is applicable to that person.
- 26 Enacting section 1. This amendatory act takes effect 90 days
- 27 after the date it is enacted into law.

- 1 Enacting section 2. This amendatory act does not take effect
- 2 unless Senate Bill No. \_\_\_\_ or House Bill No. 6205 (request no.
- 3 04193'17) of the 99th Legislature is enacted into law.
