## SENATE SUBSTITUTE FOR HOUSE BILL NO. 6216

A bill to amend 1996 PA 199, entitled "Michigan aquaculture development act," by amending sections 6 and 8 (MCL 286.876 and 286.878).

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 6. (1) A person shall not engage in aquaculture unless he
- 2 or she obtains a registration from the department as an aquaculture
- 3 facility, obtains an aquaculture research permit, or unless
- 4 otherwise exempt by rule or law. If the activity in which the
- 5 aquaculture facility is engaged is required to be regulated under
- 6 any act, registration under this act does not exempt the person or
- 7 aquaculture facility from requirements imposed under any local,
- 8 state, or federal regulation.
- 9 (2) The following are exempt from registration as an
- 10 aquaculture facility:

- 1 (a) Retail bait outlets.
- 2 (b) Retail ornamental fish facilities.
- 3 (c) Persons using privately controlled waters for
- 4 noncommercial purposes.
- 5 (d) Public aquariums or zoos.
- **6** (e) Portable retail fishing concessions.
- 7 (3) A person registered or permitted under this act shall keep
- 8 and maintain records of production, purchases, or imports in order
- 9 to establish proof of ownership. A person transporting aquaculture
- 10 species shall produce documentation that contains the origin of
- 11 shipment, registration or permit copies or documentation,
- 12 documentation demonstrating shipping destination, and any other
- 13 proof that may be required under the animal industry act, of 1987,
- 14 Act No. 466 of the Public Acts of 1988, being sections 287.701 to
- 15 287.747 of the Michigan Compiled Laws, 1988 PA 466, MCL 287.701 TO
- 16 287.747, upon demand of the director or a law enforcement officer.
- 17 (4) An aquaculture facility in existence before January 1,
- 18 1997 is required to obtain a registration or permit, or both, if
- 19 applicable, by January 1, 1999 in order to continue to engage in
- 20 aquaculture. Any person engaging in aquaculture beginning on or
- 21 after January 1, 1997 is required to obtain a registration or
- 22 permit under this act, or both, if applicable, in order to engage
- 23 in aquaculture.
- Sec. 8. (1) Research of an aquaculture species not on the
- 25 approved list is allowed and shall be conducted pursuant to an
- 26 aquaculture research permit in a confinement research facility.
- 27 (2) A person who holds an aquaculture research permit shall

- 1 not import aquaculture species that are the subject of the research
- 2 unless he or she complies with the animal industry act, of 1987,
- 3 Act No. 466 of the Public Acts of 1988, being sections 287.701 to
- 4 287.747 of the Michigan Compiled Laws.1988 PA 466, MCL 287.701 TO
- 5 287.747.
- **6** (3) The director shall approve the protocol of the aquaculture
- 7 species, including disposition, for the proposed research period.
- 8 The applicant for the aquaculture research permit shall submit the
- 9 protocol to the department with the initial or renewal aquaculture
- 10 research permit application.
- 11 Enacting section 1. This amendatory act takes effect 90 days
- 12 after the date it is enacted into law.
- 13 Enacting section 2. This amendatory act does not take effect
- 14 unless House Bill No. 6205 of the 99th Legislature is enacted into
- **15** law.
