## SENATE SUBSTITUTE FOR HOUSE BILL NO. 6212

## A bill to amend 1994 PA 358, entitled

"An act to regulate the possession of ferrets; to provide for the licensing of ferrets; to provide for requirements for importation and rabies control procedures for ferrets; to provide for the powers and duties of certain governmental entities; to prescribe penalties and provide remedies; and to repeal acts and parts of acts,"

by amending section 1 (MCL 287.891).

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. (1) "Accredited veterinarian" means a veterinarian
- 2 approved by the United States department of agriculture DEPARTMENT
- 3 OF AGRICULTURE to perform specific functions required by
- 4 cooperative state and federal disease control and eradication
- 5 programs.
- 6 (2) "Animal" means an animal other than a human being.
- 7 (3) "Animal control officer" means an individual employed as

- 1 an animal control officer pursuant to UNDER sections 29a, 29b, and
- 2 29c of the dog law of 1919, Act No. 339 of the Public Acts of 1919,
- 3 being sections 287.289a, 287.289b, and 287.289c of the Michigan
- 4 Compiled Laws. 1919 PA 339, MCL 287.289A, 287.289B, AND 287.289C.
- 5 (4) "Approved vaccine" means a vaccine authorized by the state
- 6 veterinarian pursuant to UNDER the animal industry act, of 1987,
- 7 Act No. 466 of the Public Acts of 1988, being sections 287.701 to
- 8 287.747 of the Michigan Compiled Laws. 1988 PA 466, MCL 287.701 TO
- 9 287.747.
- 10 (5) "Breeder" means a person who is a dealer as defined in the
- 11 animal welfare act, Public Law 89-544, 7 U.S.C. USC 2131 to 2147,
- 12 2149, and 2151 to 2159, and who is regulated by the United States
- 13 department of agriculture DEPARTMENT OF AGRICULTURE as a class A
- 14 licensee, breeder, or a class B licensee , meeting the definition
- 15 of dealer in §1.1, pursuant to title 9, C.F.R., subchapter A, part
- 16 1, section 1.1 and subpart F, sections 3.125 through 3.142.9 CFR
- 17 1.1 AND WHO IS REGULATED BY THE UNITED STATES DEPARTMENT OF
- 18 AGRICULTURE UNDER 9 CFR PART 3.
- 19 (6) "Department" means the department of agriculture AND RURAL
- 20 DEVELOPMENT.
- 21 (7) "Director" means the director of the department of
- 22 agriculture or his or her authorized representative.
- 23 (8) "Ferret" means an animal of any age of the species Mustela
- 24 furo.
- 25 (9) "Hobby breeder" means a person who owns 4 or fewer ferrets
- 26 that are at least 6 months of age or a litter of ferrets that is
- 27 less than 5 months of age on a temporary basis for personal

- 1 recreational purposes such as INCLUDING, BUT NOT LIMITED TO,
- 2 competitions in shows or improving the breed, and who registers his
- 3 or her ferrets with a national ferret registry organization.
- 4 (10) "Law enforcement agent" means an officer of the
- 5 department of state police, a law enforcement agency of a county,
- 6 township, city, or village who is responsible for the prevention
- 7 and detection of crime and enforcement of the criminal laws of this
- 8 state, or a conservation officer.
- 9 (11) "Local unit of government" means a county, city, village,
- 10 or township.
- 11 (12) "Official interstate health certificate" or "official
- 12 certificate of veterinary inspection" means a printed form that is
- 13 adopted by any state that documents the information described in
- 14 this subsection and that is issued by an accredited veterinarian
- 15 for animals being imported or exported from this state within 30
- 16 days before the importation or exportation of the animals it
- 17 describes. A photocopy of an official interstate health certificate
- 18 or official certificate of veterinary inspection is not valid. An
- 19 official interstate health certificate or official certificate of
- 20 veterinary inspection shall include all of the following:
- 21 (a) The complete names and addresses of the consignor and
- 22 consignee and the destination address if different from the
- 23 consignee address.
- 24 (b) A description of the ferret by breed, sex, age, color,
- 25 markings, and other identification.
- 26 (c) The date of examination of the ferret by the accredited
- 27 veterinarian preparing the certificate.

- 1 (d) The health status of the ferret by recording the results
- 2 of any required tests and required vaccinations. The accredited
- 3 veterinarian preparing the certificate shall certify that the
- 4 ferret is free from clinical signs of infectious, contagious, or
- 5 toxicological diseases.
- 6 (13) "Owner" means a person having a right of property
- 7 ownership in a ferret, who keeps or harbors the ferret or has the
- 8 ferret in his or her care or custody, or who permits the ferret to
- 9 remain on or about premises occupied by the person. An owner does
- 10 not include a veterinarian who keeps a ferret on a temporary basis
- 11 for medical care or treatment.
- 12 (14) "Person" means an individual, partnership, corporation,
- 13 association, governmental entity, or other legal entity.
- 14 (15) "State veterinarian" means the chief animal health
- 15 official of the state as appointed by the director under section 7
- 16 of the animal industry act, of 1987, Act No. 466 of the Public Acts
- 17 of 1988, being section 287.707 of the Michigan Compiled Laws.1988
- 18 PA 466, MCL 287.707.
- 19 (16) "Veterinarian" means a person licensed to practice
- 20 veterinary medicine under article 15 of the public health code, Act
- 21 No. 368 of the Public Acts of 1978, being sections 333.16101 to
- 22 333.18838 of the Michigan Compiled Laws, 1978 PA 368, MCL 333.16101
- 23 TO 333.18838, or under the law of another state or federal
- 24 authority that is applicable to that person.
- 25 Enacting section 1. This amendatory act takes effect 90 days
- 26 after the date it is enacted into law.
- 27 Enacting section 2. This amendatory act does not take effect

- 1 unless House Bill No. 6205 of the 99th Legislature is enacted into
- 2 law.
