- 26 pursuant to the public information reporting requirements under the
- 27 crime awareness and campus security act of 1990, title II of the

- 3 (d) A list of all positions funded partially or wholly through
- 4 institutional general fund revenue that includes the position title
- 5 and annual salary or wage amount for each position.

- 7 current fiscal year and the next fiscal year.
- 8 (f) A listing of all debt service obligations, detailed by
- 9 project, anticipated fiscal year payment for each project, and
- 10 total outstanding debt for the current fiscal year.
