HOUSE BILL NO. 4236**

A bill to amend 1979 PA 94, entitled
"The state school aid act of 1979,"
by amending sections 236 and 236a (MCL 388.1836 and 388.1836a), as
amended by 2018 PA 265.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 236. ~~(1)~~—Subject to the conditions set forth in this
2 article, the amounts listed in this section are appropriated for
3 higher education for the fiscal year ending September 30, ~~2019,~~
4 **2020**, from the funds indicated in this section. The following is a

 17 ~~appropriated from the state school aid fund. A university that~~
 18 ~~receives money under this subsection shall use that money solely~~
 19 ~~for the purpose of offsetting the normal cost contribution rate. As~~
 20 ~~used in this subsection, "participating public universities" means~~
 21 ~~public universities that are a reporting unit of the Michigan~~
 22 ~~public school employees' retirement system under the public school~~
 23 ~~employees retirement act of 1979, 1980 PA 300, MCL 38.1301 to~~
 24 ~~38.1437, and that pay contributions to the Michigan public school~~
 25 ~~employees' retirement system for the state fiscal year.~~

26 Sec. 236a. It is the intent of the legislature to provide
 27 appropriations for the fiscal year ending on September 30, 2020
 28 **2021** for the items listed in section 236. The fiscal year 2019-2020
 29 **2020-2021** appropriations are anticipated to be the same as those



1 for fiscal year ~~2018-2019~~, **2019-2020**, except that the amounts will
2 be adjusted for changes in caseload and related costs, federal fund
3 match rates, economic factors, and available revenue. These
4 adjustments will be determined after the January ~~2019~~**2020**
5 consensus revenue estimating conference.
