

**SENATE SUBSTITUTE FOR
HOUSE BILL NO. 4431**

A bill to amend 1972 PA 382, entitled
"Traxler-McCauley-Law-Bowman bingo act,"
by amending section 3 (MCL 432.103), as amended by 2019 PA 159.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 3. As used in this act:

2 (a) "Large bingo" means a series of bingo occasions that occur
3 on a regular basis during which the total value of all prizes
4 awarded for bingo games at a single occasion does not exceed
5 \$3,500.00 and the total value of all prizes awarded for 1 bingo
6 game does not exceed \$1,100.00, except that a prize awarded through
7 a Michigan progressive jackpot bingo game is not subject to these
8 limitations.

9 (b) "Large raffle" means an event ~~where~~ **at which** the total



1 value of all prizes awarded through raffle drawings exceeds \$500.00
2 per occasion.

3 (c) "Licensee" means a person, including a qualified
4 organization, licensed under this act.

5 (d) "Location" means a building, enclosure, part of a building
6 or enclosure, or a distinct portion of real property that is used
7 for the purpose of conducting an event. Location includes all
8 components or buildings that compose 1 architectural entity or that
9 serve a unified functional purpose.

10 (e) "Manufacturer" means a person licensed under section 11c
11 ~~who~~**that** manufactures numeral game tickets for sale to suppliers
12 for use in an event.

13 (f) "Member" means an individual who qualified for membership
14 in a qualified organization under its bylaws, articles of
15 incorporation, charter, rules, or other written statement.

16 (g) "Michigan national guard" and "military" mean those terms
17 as defined in section 105 of the Michigan military act, 1967 PA
18 150, MCL 32.505.

19 (h) "Michigan progressive jackpot" means a bingo game
20 conducted in conjunction with a licensed large bingo occasion in
21 which the value of the prize is carried forward to the next bingo
22 occasion if no player wins in a predetermined number of allowable
23 calls. Michigan progressive jackpot may include bingo games
24 conducted by more than 1 licensee that are linked together for the
25 purpose of a common jackpot prize and consolation prize as
26 prescribed by the commissioner.

27 (i) "Millionaire party" means an event at which wagers are
28 placed on games of chance customarily associated with a gambling
29 casino through the use of imitation money or chips that have a



1 nominal value equal to or greater than the value of the currency
2 for which they can be exchanged.

3 (j) "Numeral game" means the random resale of a series of
4 numeral game tickets.

5 (k) "Numeral game ticket" means a paper strip on which
6 preprinted numerals are covered by folding the strip and banding
7 the folded strip with a separate piece of paper, so that on
8 breaking the paper that bands the ~~folding~~ **folded** strip the
9 purchaser discovers whether the ticket is a winning ticket.
10 (l) "Occasion" means ~~a single~~ **the hours of the** day for which a
11 license ~~to conduct games is issued. under this act.~~
