## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 TITLE

- 2 An act to authorize public corporations to purchase,
- 3 acquire, construct, improve, enlarge, extend, or repair public
- 4 improvements within or without their corporate limits, and to

- 1 to provide for a pledge by public corporations of their full
- 2 faith and credit and the levy of taxes without limitation as to
- 3 rate or amount to the extent necessary for the payment of the
- 4 bonds, or for advancing money from general funds for payment of

- 6 bonds; to provide for the imposition of special assessment bonds
- 7 for the purpose of refunding outstanding revenue bonds; to pre-
