SENATE SUBSTITUTE FOR HOUSE BILL NO. 5228

A bill to amend 1976 PA 451, entitled "The revised school code," by amending section 1279 (MCL 380.1279), as amended by 1997 PA 25.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1279. (1) The board of a school district or public
- 2 school academy shall award a state-endorsed high school diploma
- 3 to an eligible high school graduate as provided in this section.
- 4 ADMINISTER STATE ASSESSMENTS TO HIGH SCHOOL PUPILS IN THE SUBJECT
- 5 AREAS OF COMMUNICATIONS SKILLS, MATHEMATICS, SCIENCE, AND, BEGIN-
- 6 NING WITH PUPILS SCHEDULED TO GRADUATE IN 2000, SOCIAL STUDIES.
- 7 THE BOARD SHALL INCLUDE ON THE PUPIL'S HIGH SCHOOL TRANSCRIPT ALL
- 8 OF THE FOLLOWING:

- 1 (A) FOR EACH HIGH SCHOOL GRADUATE WHO HAS COMPLETED A
- 2 SUBJECT AREA ASSESSMENT UNDER THIS SECTION, THE PUPIL'S SCALED
- 3 SCORE ON THE ASSESSMENT.
- 4 (B) IF THE PUPIL'S SCALED SCORE ON A SUBJECT AREA ASSESSMENT
- 5 FALLS WITHIN THE RANGE REQUIRED UNDER SUBSECTION (2) FOR A CATE-
- 6 GORY ESTABLISHED UNDER SUBSECTION (2), AN INDICATION THAT THE
- 7 PUPIL HAS ACHIEVED STATE ENDORSEMENT FOR THAT SUBJECT AREA.
- 8 (C) THE NUMBER OF SCHOOL DAYS THE PUPIL WAS IN ATTENDANCE AT
- 9 SCHOOL EACH SCHOOL YEAR DURING HIGH SCHOOL AND THE TOTAL NUMBER
- 10 OF SCHOOL DAYS IN SESSION FOR EACH OF THOSE SCHOOL YEARS.
- 11 (2) For pupils scheduled to graduate from high school in
- 12 1997, if a pupil achieves the academic objectives required by the
- 13 state board, as measured by an assessment developed under
- 14 subsection (7), for a state-endorsed high school diploma, or
- 15 meets the requirements described in former subsection (1)(c) for
- 16 a state-endorsed diploma, in 1 or more of the subject areas of
- 17 communications skills, mathematics, and science, the pupil's
- 18 school district or public school academy shall award a state
- 19 endorsement on the pupil's diploma in each of the subject areas
- 20 in which the pupil demonstrated the required proficiency.
- 21 Beginning with pupils scheduled to graduate in 1998, if a pupil
- 22 achieves the objectives required by the state board, as measured
- 23 by an assessment instrument developed under subsection (7), for
- 24 a state-endorsed high school diploma in 1 or more of the subject
- 25 areas of communications skills, mathematics, science, and, begin-
- 26 ning with pupils scheduled to graduate in 2000, social studies,
- 27 the pupil's school district or public school academy shall award

1 a state endorsement on the pupil's diploma in each of the subject

- 2 areas in which the pupil demonstrated the required proficiency.
- 3 A school district or public school academy shall not award a
- 4 state endorsement to a pupil unless the pupil meets the applica-
- 5 ble requirements for the endorsement, as described in this
- 6 subsection. THE DEPARTMENT SHALL DEVELOP SCALED SCORES FOR
- 7 REPORTING SUBJECT AREA ASSESSMENT RESULTS FOR EACH OF THE SUBJECT
- 8 AREAS UNDER THIS SECTION. SUBJECT TO APPROVAL BY THE STATE BOARD, THE SUPERINTENDENT OF PUBLIC INSTRUC-
- 9 TION SHALL ESTABLISH 3 CATEGORIES FOR EACH SUBJECT AREA INDICAT-
- 10 ING BASIC COMPETENCY, ABOVE AVERAGE, AND OUTSTANDING, AND SHALL
- 11 ESTABLISH THE SCALED SCORE RANGE REQUIRED FOR EACH CATEGORY. THE
- 12 DEPARTMENT SHALL DESIGN AND DISTRIBUTE TO SCHOOL DISTRICTS,
- 13 INTERMEDIATE SCHOOL DISTRICTS, PUBLIC SCHOOL ACADEMIES, AND NON-
- 14 PUBLIC SCHOOLS A SIMPLE AND CONCISE DOCUMENT THAT DESCRIBES THESE
- 15 CATEGORIES IN EACH SUBJECT AREA AND INDICATES THE SCALED SCORE
- 16 RANGES FOR EACH CATEGORY IN EACH SUBJECT AREA. A school district
- 17 or public school academy may award a high school diploma to a
- 18 pupil who successfully completes local school district or public
- 19 school academy requirements established in accordance with state
- 20 law for high school graduation, regardless of whether the pupil
- 21 is eligible for any state endorsement.
- 22 (3) THE ASSESSMENTS ADMINISTERED FOR THE PURPOSES OF THIS
- 23 SECTION SHALL BE ADMINISTERED TO PUPILS DURING THE LAST 30 SCHOOL
- 24 DAYS OF GRADE 11. THE DEPARTMENT SHALL ENSURE THAT THE ASSESS-
- 25 MENTS ARE SCORED AND THE SCORES ARE RETURNED TO PUPILS, THEIR
- 26 PARENTS OR LEGAL GUARDIANS, AND SCHOOL DISTRICTS OR PUBLIC SCHOOL
- 27 ACADEMIES NOT LATER THAN THE BEGINNING OF THE PUPIL'S FIRST

- 1 SEMESTER OF GRADE 12. NOT LATER THAN FALL 1999, THE DEPARTMENT
- 2 SHALL ARRANGE FOR THOSE PORTIONS OF A PUPIL'S ASSESSMENT THAT
- 3 CANNOT BE SCORED MECHANICALLY TO BE SCORED IN MICHIGAN BY PERSONS
- 4 WHO ARE MICHIGAN TEACHERS, RETIRED MICHIGAN TEACHERS, OR MICHIGAN
- 5 SCHOOL ADMINISTRATORS AND WHO HAVE BEEN TRAINED IN SCORING THE
- 6 ASSESSMENTS. THE RETURNED SCORES SHALL INDICATE THE PUPIL'S
- 7 SCALED SCORE FOR EACH SUBJECT AREA ASSESSMENT, THE RANGE OF
- 8 SCALED SCORES FOR EACH SUBJECT AREA, AND THE RANGE OF SCALED
- 9 SCORES REQUIRED FOR EACH CATEGORY ESTABLISHED UNDER
- 10 SUBSECTION (2). IN REPORTING THE SCORES TO PUPILS, PARENTS, AND
- 11 SCHOOLS, THE DEPARTMENT SHALL PROVIDE SPECIFIC, MEANINGFUL, AND
- 12 TIMELY FEEDBACK ON THE PUPIL'S PERFORMANCE ON THE ASSESSMENT.
- 13 (4) (3) A pupil who does not achieve the requirements of
- 14 subsection (2) may be reevaluated each school year until the
- 15 pupil achieves an applicable requirement for a state-endorsed
- 16 diploma. In addition FOR EACH PUPIL WHO DOES NOT ACHIEVE STATE
- 17 ENDORSEMENT IN 1 OR MORE SUBJECT AREAS, the board of the school
- 18 district or public school academy in which the pupil is enrolled
- 19 shall provide that there be at least 1 meeting attended by at
- 20 least the pupil and a member of the school district's or public
- 21 school academy's staff or a local or intermediate school district
- 22 consultant who is proficient in the measurement and evaluation of
- 23 pupils. The school district or public school academy may provide
- 24 the meeting as a group meeting for pupils in similar
- 25 circumstances. If the pupil is a minor, the school district or
- 26 public school academy shall invite and encourage the pupil's
- 27 parent, legal guardian, or person in loco parentis to attend the

- 1 meeting and shall mail a notice of the meeting to the pupil's
- 2 parent, legal guardian, or person in loco parentis. The purpose
- 3 of this meeting and any subsequent meeting under this subsection
- 4 shall be to determine an educational program for the pupil
- 5 designed to have the pupil -reach proficiency ACHIEVE STATE
- **6** ENDORSEMENT in each subject or skill area in which he or she
- 7 was assessed by the testing as not proficient DID NOT ACHIEVE
- 8 STATE ENDORSEMENT. In addition, a school district or public
- 9 school academy may provide for subsequent meetings with the pupil
- 10 conducted by a high school counselor or teacher designated by the
- 11 pupil's high school principal, and shall invite and encourage the
- 12 pupil's parent, legal guardian, or person in loco parentis to
- 13 attend the subsequent meetings. The school district or public
- 14 school academy shall provide special programs for the pupil or
- 15 develop a program using the educational programs regularly pro-
- 16 vided by the district unless the board of the school district or
- 17 public school academy decides otherwise and publishes and
- 18 explains its decision in a public justification report.
- 19 (5) A pupil may be reevaluated WHO WANTS TO REPEAT AN
- 20 ASSESSMENT ADMINISTERED UNDER THIS SECTION MAY REPEAT THE ASSESS-
- 21 MENT, WITHOUT CHARGE TO THE PUPIL, IN THE NEXT SCHOOL YEAR OR
- 22 AFTER GRADUATION. AN INDIVIDUAL MAY REPEAT AN ASSESSMENT at any
- 23 time the school district or public school academy administers an
- 24 applicable assessment instrument OR DURING A RETESTING PERIOD
- 25 UNDER SUBSECTION (7).
- 26 (4) For a state-endorsed diploma, a pupil must achieve the
- 27 requirements of subsection (2) in addition to any other

- 1 requirements established by law or by the board of the school
- 2 district or public school academy for a high school diploma. If
- 3 the board of a school district or public school academy deter-
- 4 mines that a pupil qualifies for a state-endorsed diploma, the
- 5 board shall indicate on the pupil's high school diploma and tran-
- 6 script that the pupil achieved the proficiency necessary for
- 7 receipt of a state-endorsed diploma.
- 8 (5) An individual may repeat any of the tests or assessment
- 9 instruments specified in subsection (2) at any time the school
- 10 district or public school academy regularly offers the test or
- 11 assessment. If an individual described in this subsection
- 12 achieves the requirements of subsection (2) and completes all
- 13 other applicable requirements for a high school diploma, the
- 14 individual shall be awarded a state-endorsed diploma as otherwise
- 15 provided in this section.
- 16 (6) THE DEPARTMENT SHALL ENSURE THAT THE LENGTH OF THE
- 17 ASSESSMENTS USED FOR THE PURPOSES OF THIS SECTION AND THE COM-
- 18 BINED TOTAL TIME NECESSARY TO ADMINISTER ALL OF THE ASSESSMENTS,
- 19 INCLUDING SOCIAL STUDIES, ARE THE SHORTEST POSSIBLE THAT WILL
- 20 STILL MAINTAIN THE DEGREE OF RELIABILITY AND VALIDITY OF THE
- 21 ASSESSMENT RESULTS DETERMINED NECESSARY BY THE DEPARTMENT. THE
- 22 DEPARTMENT SHALL ENSURE THAT THE MAXIMUM TOTAL COMBINED LENGTH OF
- 23 TIME THAT SCHOOLS ARE REQUIRED TO SET ASIDE FOR ADMINISTRATION OF
- 24 ALL OF THE ASSESSMENTS USED FOR THE PURPOSES OF THIS SECTION,
- 25 INCLUDING SOCIAL STUDIES, DOES NOT EXCEED 8 HOURS. HOWEVER, THIS
- 26 SUBSECTION DOES NOT LIMIT THE AMOUNT OF TIME THAT INDIVIDUALS MAY
- 27 HAVE TO COMPLETE THE ASSESSMENTS.

- 1 (7) THE DEPARTMENT SHALL ESTABLISH, SCHEDULE, AND ARRANGE
- 2 PERIODIC RETESTING PERIODS THROUGHOUT THE YEAR FOR INDIVIDUALS
- 3 WHO DESIRE TO REPEAT AN ASSESSMENT UNDER THIS SECTION. THE
- 4 DEPARTMENT SHALL COORDINATE THE ARRANGEMENTS FOR ADMINISTERING
- 5 THE REPEAT ASSESSMENTS AND SHALL ENSURE THAT THE RETESTING IS
- 6 MADE AVAILABLE AT LEAST WITHIN EACH INTERMEDIATE SCHOOL DISTRICT
- 7 AND, TO THE EXTENT POSSIBLE, WITHIN EACH SCHOOL DISTRICT.
- **8** (8) (6) A school district or public school academy shall
- 9 provide accommodations to a pupil with disabilities for the
- 10 proficiency testing or assessment ASSESSMENTS required under
- 11 this section, as provided under section 504 of title V of the
- 12 rehabilitation act of 1973, Public Law 93-112, 29 U.S.C. 794;
- 13 subtitle A of title II of the Americans with disabilities act of
- 14 1990, Public Law 101-336, 42 U.S.C. 12131 to 12134; and the
- 15 implementing regulations for those statutes.
- 16 (9) $\frac{(7)}{(7)}$ For the purposes of this section, the state board
- 17 shall develop or select and approve assessment instruments to
- 18 determine pupil proficiency MEASURE PUPIL PERFORMANCE in commu-
- 19 nications skills, mathematics, social studies, and science. The
- 20 assessment instruments shall be based on the state board model
- 21 core academic content standards objectives.
- 22 (10) $\overline{(8)}$ All assessment instruments developed or selected
- 23 and approved by the state under any statute or rule for a purpose
- 24 related to K to 12 education shall be objective-oriented and con-
- 25 sistent with the state board model core academic content stan-
- 26 dards objectives.

- 1 (11) (9) Upon payment of a reasonable fee any person may
- 2 take the state-endorsed diploma test and, upon demonstrating the
- 3 required proficiency in a subject area, have his or her high
- 4 school diploma state-endorsed for that subject area. A PERSON
- 5 WHO HAS GRADUATED FROM HIGH SCHOOL AFTER 1996 AND WHO HAS NOT
- 6 PREVIOUSLY TAKEN AN ASSESSMENT UNDER THIS SECTION MAY TAKE AN
- 7 ASSESSMENT USED FOR THE PURPOSES OF THIS SECTION, WITHOUT CHARGE
- 8 TO THE PERSON, AT THE SCHOOL DISTRICT FROM WHICH HE OR SHE GRADU-
- 9 ATED FROM HIGH SCHOOL AT ANY TIME THAT SCHOOL DISTRICT ADMINIS-
- 10 TERS THE ASSESSMENT OR DURING A RETESTING PERIOD SCHEDULED UNDER
- 11 SUBSECTION (7) AND HAVE HIS OR HER SCALED SCORE ON THE ASSESSMENT
- 12 INCLUDED ON HIS OR HER HIGH SCHOOL TRANSCRIPT. IF THE PERSON'S
- 13 SCALED SCORE ON A SUBJECT AREA ASSESSMENT FALLS WITHIN THE RANGE
- 14 REQUIRED UNDER SUBSECTION (2) FOR A CATEGORY ESTABLISHED UNDER
- 15 SUBSECTION (2), THE SCHOOL DISTRICT SHALL ALSO INDICATE ON THE
- 16 PERSON'S HIGH SCHOOL TRANSCRIPT THAT THE PERSON HAS ACHIEVED
- 17 STATE ENDORSEMENT FOR THAT SUBJECT AREA.
- 18 (12) NOT LATER THAN JULY 1 OF EACH YEAR UNTIL 2000, THE
- 19 DEPARTMENT SHALL SUBMIT A COMPREHENSIVE REPORT TO THE LEGISLATURE
- 20 ON THE STATUS OF THE ASSESSMENT PROGRAM UNDER THIS SECTION. THE
- 21 REPORT SHALL INCLUDE AT LEAST ALL OF THE FOLLOWING:
- 22 (A) THE ANNUAL PUPIL ASSESSMENT DATA.
- 23 (B) A DESCRIPTION OF THE FEEDBACK PROVIDED TO PUPILS, PAR-
- 24 ENTS, AND SCHOOLS.
- 25 (C) A DESCRIPTION OF ANY SIGNIFICANT ALTERATIONS MADE IN THE
- 26 PROGRAM BY THE DEPARTMENT OR STATE BOARD DURING THE PERIOD
- 27 COVERED BY THE REPORT.
