A bill to amend 1976 PA 451, entitled "The revised school code," by amending section 1282 (MCL 380.1282), as amended by 1993 PA 335.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 1282. (1) The board of a school district shall estab-
- 2 lish and carry on the grades, schools, and departments it consid-
- 3 ers necessary or desirable for the maintenance and improvement of
- 4 its schools and determine the courses of study to be pursued.
- 5 (2) The board of a school district shall provide a core aca-
- 6 demic curriculum, learning processes, special assistance,
- 7 PARTICULARLY FOR STUDENTS WITH READING DISORDERS OR WHO HAVE DEMONSTRATED MARKED DIFFICULTY IN ACHIEVING SUCCESS ON STANDARDIZED TESTS, and sufficient
- 8 access to each of these so that all pupils have a fair
- 9 opportunity to achieve a state-endorsed diploma STATE
- 10 ENDORSEMENT UNDER SECTION 1279. THE BOARD SHALL USE MICHIGAN

- 12 SHALL INVITE AND ENCOURAGE THE PUPIL'S PARENT, LEGAL GUARDIAN, OR

- 19 IN ADDITION, THE SCHOOL DISTRICT MAY PROVIDE FOR SUBSEQUENT MEET-
- 20 INGS WITH THE PUPIL CONDUCTED BY A COUNSELOR OR TEACHER DESIG-
- 21 NATED BY THE PUPIL'S PRINCIPAL, AND SHALL INVITE AND ENCOURAGE
- 22 THE PUPIL'S PARENT, LEGAL GUARDIAN, OR PERSON IN LOCO PARENTIS TO
- 23 ATTEND THE SUBSEQUENT MEETINGS. THE SCHOOL DISTRICT MAY PROVIDE
- 24 SPECIAL PROGRAMS FOR THE PUPIL OR DEVELOP A PROGRAM USING THE
- 25 EDUCATIONAL PROGRAMS REGULARLY PROVIDED BY THE SCHOOL DISTRICT.
