SUBSTITUTE FOR HOUSE BILL NO. 5871

A bill to provide for the sale of real and personal property for less than its market value by a local governmental unit to a nonprofit charitable organization under certain circumstances.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 5 (c) "Real property" means land and any structure, appurte-
- 6 nance, or personal property located on the land.
- 7 Sec. 3. (1) After holding a public hearing on the issue
- 8 pursuant to the open meetings act, 1976 PA 267, MCL 15.261 to
- 9 15.275, a local governmental unit may convey its interest in real
- 10 property for any consideration it considers appropriate, which
- 11 may be less than its fair market value, to a nonprofit organiza-
- 12 tion for any of the following purposes as set forth in the con-
- 13 veyance agreement:
- 14 (a) Constructing new or rehabilitated housing designed to
- 15 increase the supply of [senior and] affordable housing within the local gov-
- 16 ernmental unit.

- 25 (2) A conveyance under subsection (1) is a conveyance for a
