SUBSTITUTE FOR SENATE BILL NO. 680

A bill to amend 1998 PA 58, entitled "The Michigan liquor control code of 1998," (MCL 436.1101 to 436.2303) by adding section 704.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 704. (1) A PERSON SHALL NOT CONSUME OR POSSESS ALCO-
- 2 HOLIC LIQUOR ON SCHOOL PROPERTY IF BOTH OF THE FOLLOWING CIRCUM-

- 4 (A) THE SCHOOL DISTRICT HAS ADOPTED A FORMAL POLICY PROHIB-
- 5 ITING THE CONSUMPTION AND POSSESSION OF ALCOHOLIC LIQUOR ON ALL
- 6 SCHOOL PROPERTY IN THE SCHOOL DISTRICT.
- 7 (B) THE SCHOOL DISTRICT HAS POSTED A CONSPICUOUS SIGN AT ALL
- 8 ENTRANCES TO SCHOOL PROPERTY, INCLUDING EACH PUBLIC ENTRANCE TO A
- 9 SCHOOL BUILDING, STATING THAT THE CONSUMPTION AND POSSESSION OF
- 10 ALCOHOLIC LIQUOR ARE PROHIBITED ON THAT SCHOOL PROPERTY.

- (B) "SCHOOL PROPERTY" MEANS A BUILDING, FACILITY, OR STRUC-21
- 22 TURE AND OTHER REAL ESTATE OWNED, LEASED, OR OTHERWISE CONTROLLED
- 23 BY A SCHOOL DISTRICT. SCHOOL PROPERTY DOES NOT INCLUDE A PRIVATE
- 24 RESIDENCE.
