 STATE FOR A SPECIAL REGISTRATION PLATE. THE SPECIAL REGISTRATION
 PLATE SHALL HAVE THE WORDS "HONORARY CONSUL" INSCRIBED BENEATH
 THE REGISTRATION LETTERS AND NUMBERS.

- **19** REQUIRED TO FURNISH THE PROOF PROVIDED IN SUBSECTION (2).
