A bill to amend 1961 PA 236, entitled "Revised judicature act of 1961,"
(MCL 600.101 to 600.9948) by adding section 2567b.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 2567B. (1) UPON A CONVEYANCE OR TRANSFER OF TITLE, OR
- 2 FILING OF CLAIM OF CONTINUANCY INTEREST, OF A PRESENT OR FUTURE
- 3 INTEREST IN MINERAL RIGHTS OR A PORTION OF INTEREST IN THOSE
- 4 RIGHTS, INCLUDING THE BENEFICIAL USE OF THE INTEREST, EACH PERSON
- 5 IN THIS STATE WHO OWNS SEVERED MINERAL RIGHTS SHALL PROVIDE THE
- 6 REGISTER OF DEEDS IN THE COUNTY IN WHICH THE PROPERTY IS LOCATED
- 7 WITH THE LEGAL DESCRIPTION OF THE REAL PROPERTY AND THE NAME AND
- 8 ADDRESS OF THE HOLDER OF THE SEVERED MINERAL RIGHTS. THE COUNTY
- 9 SHALL COMPILE THIS INFORMATION TO USE TO ASSURE COMPLIANCE WITH
- 10 SUBSECTION (2).

- 26 (D) TO PURCHASE MINERAL RIGHTS FROM THE STATE ON LANDS
- 27 WITHIN THE COUNTY OR A LOCAL GOVERNMENTAL UNIT WITHIN THE COUNTY,

- 1 WHEN THE LOCAL GOVERNMENTAL UNIT HOLDS THE SURFACE INTEREST BUT
- 2 THE STATE OWNS THE MINERAL RIGHTS.
- 3 (5) AS USED IN THIS SECTION, "MINERAL RIGHTS" MEANS SUBSUR-
- 4 FACE OIL OR GAS INTERESTS.
