## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 171B. (1) IF A PROPOSED CONDOMINIUM PROJECT INCLUDES
- 2 OR ABUTS ROADS UNDER THE JURISDICTION OF THE COUNTY ROAD COMMIS-
- 3 SION, THE DEVELOPER SHALL SUBMIT 3 COPIES OF THE PROPOSED PROJECT
- 4 TO THE ENGINEER OR CHAIRPERSON OF THE COUNTY ROAD COMMISSION.
- 5 (2) THE COUNTY ROAD COMMISSION MAY ALSO REQUIRE TO BE SUB-
- 6 MITTED WITH THE PROPOSED CONDOMINIUM PROJECT A TOPOGRAPHIC MAP
- 7 SHOWING DIRECTION OF DRAINAGE AND PROPOSED WIDTHS OF ROADS UNDER
- 8 ITS JURISDICTION OR TO COME UNDER ITS JURISDICTION AND PRIVATE
- 9 ROADS IN UNINCORPORATED AREAS.
- 10 (3) WITHIN 30 DAYS AFTER RECEIPT OF THE PROPOSED PROJECT,
- 11 THE COUNTY ROAD COMMISSION SHALL APPROVE IT AND NOTE ITS APPROVAL

- 16 CLAIMS ARISING OUT OF THE TOWNSHIP'S PERFORMANCE OF THE FUNCTIONS
- 17 LISTED IN SUBSECTION (4). AN ORDINANCE UNDER SUBSECTION (4) DOES
- 18 NOT SUPERSEDE THE POWERS AND DUTIES OF THE COUNTY ROAD COMMISSION
