 COMPARE THE SOCIAL SECURITY NUMBERS OF FOOD STAMP RECIPIENTS TO

14 (B) THE DOLLAR AMOUNT OF FOOD STAMPS THAT WERE PAID TO 15 RECIPIENTS FROM THE SOCIAL SECURITY ADMINISTRATION'S PROGRAM **16** DESCRIBED IN SUBSECTION (2).
