

**SENATE BILL NO. 986**

March 3, 1998, Introduced by Senators HOFFMAN, GOUGEON, BENNETT and SHUGARS and referred to the Committee on Hunting, Fishing and Forestry.

A bill to amend 1927 PA 372, entitled

"An act to regulate and license the selling, purchasing, possessing, and carrying of certain firearms and gas ejecting devices; to prohibit the buying, selling, or carrying of certain firearms and gas ejecting devices without a license; to provide for the forfeiture of firearms possessed in violation of this act; to provide immunity from civil liability under certain circumstances; to prescribe the powers and duties of certain state and local agencies; and to repeal all acts and parts of acts inconsistent with the provisions of this act,"

(MCL 28.421 to 28.434) by adding section 5p.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1           SEC. 5P. (1) IN ADDITION TO THE APPLICATION FEE REQUIRED  
2 UNDER THIS ACT, EACH APPLICANT FOR A LICENSE TO CARRY A CONCEALED  
3 PISTOL SHALL PAY A FEE OF \$5.00. THE FEE SHALL BE PAYABLE TO THE  
4 COUNTY. THE COUNTY TREASURER SHALL DEPOSIT THE FEE IN A CON-  
5 CEALED WEAPON AWARENESS FUND FOR THE COUNTY. THESE FUNDS SHALL  
6 BE USED ONLY FOR THE PURPOSES DESCRIBED IN SUBSECTION (2).

1 (2) THE COUNTY SHALL PROVIDE EDUCATION, TRAINING, AND OTHER  
2 PROGRAMS CONCERNING CONCEALED PISTOL LAWS, ENFORCEMENT OF THOSE  
3 LAWS, AND SAFETY FOR PEACE OFFICERS OF THE COUNTY AND LOCAL UNITS  
4 OF GOVERNMENT WITHIN THE COUNTY.

5 Enacting section 1. This amendatory act takes effect  
6 January 1, 1999.

7 Enacting section 2. This amendatory act does not take  
8 effect unless all of the following bills of the 89th Legislature  
9 are enacted into law:
