A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

(MCL 257.1 to 257.923) by adding section 803q.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 8030. (1) A PERSON WHO IS A MEMBER OF A DIPLOMATIC
- 2 CORPS OF A NATION OTHER THAN THE UNITED STATES THAT IS RECOGNIZED
- 3 BY THE GOVERNMENT OF THE UNITED STATES AND WHO IS ASSIGNED OR
- 4 STATIONED IN MICHIGAN MAY MAKE APPLICATION TO THE SECRETARY OF
- 5 STATE FOR A SPECIAL REGISTRATION PLATE. THE SPECIAL REGISTRATION
- 6 PLATE SHALL DISPLAY THE CAPITALIZED LETTERS "DPL" PRECEDING THE
- 7 REGISTRATION NUMBERS AND SHALL HAVE THE WORD "DIPLOMAT" INSCRIBED
- 8 BENEATH THE REGISTRATION LETTERS AND NUMBERS.
- 9 (2) APPLICATION FOR THE SPECIAL REGISTRATION PLATE DESCRIBED
- 10 IN SUBSECTION (1) SHALL BE ON A FORM PRESCRIBED BY THE SECRETARY
- 11 OF STATE, AND SHALL BE ACCOMPANIED BY ANY PROOF OF THE APPLICANT

- 1 BEING A FOREIGN DIPLOMAT THAT THE SECRETARY OF STATE REQUIRES.
- 2 THE APPLICATION FOR THE SPECIAL REGISTRATION PLATE SHALL ALSO BE
- 3 ACCOMPANIED BY PAYMENT OF A \$5.00 SERVICE FEE.
- 4 (3) UPON PROPER APPLICATION AND PAYMENT OF THE \$5.00 SERVICE

- 11 SUBSECTION (1) ON A VEHICLE OTHER THAN THE VEHICLE FOR WHICH THE
- 12 PLATE IS ISSUED, OR BY A PERSON WHO DOES NOT QUALIFY UNDER THIS
- 13 SECTION, IS A MISDEMEANOR.
- 14 (5) THE SPECIAL REGISTRATION PLATE ISSUED UNDER THIS SECTION
- 15 SHALL EXPIRE ON THE BIRTHDAY OF THE VEHICLE OWNER. WHEN NEW
- 16 PLATES ARE ISSUED BY THE SECRETARY OF STATE, THE APPLICATION FOR
- 17 RENEWAL OF THE SPECIAL REGISTRATION PLATE SHALL BE ACCOMPANIED BY
- 18 A \$5.00 SERVICE FEE. HOWEVER, THE APPLICANT SHALL NOT BE
- 19 REQUIRED TO FURNISH THE PROOF PROVIDED IN SUBSECTION (2).
