- Truck Safety Study. The Senate added language for a \$50,000 logging truck safety study. (Sec. 402) 3.
- 4. Gun Law Enforcement. The Senate added language requiring the training curriculum of Michigan State Troopers, police officers in the State, and in-service training of law enforcement personnel to include training on Federal firearms laws and how to turn violators over to the Federal Bureau of Alcohol, Tobacco, and Firearms. (Sec. 703)
- Hand Gun Permit Study. The Senate added language requiring a statistical study of the frequency and reasons why 5. hand gun permit applications are rejected in the State. (Sec. 1301)
- Computer Crime Grants. The Senate added language that authorizes \$300,000 to be used for computer crime 6. fighting grants to local law enforcement agencies. (Sec. 1103)
- 7. School Bus Inspections. The Senate added language requiring the School Bus Inspection Program to award certificates to school systems whose school buses all received a 100% successful safety inspection on the first try. (Sec. 1201)
- 8. Sex Offender Website. The Senate added language requiring enforcement of sex offender registry act. (Sec. 215)
- 9. Vehicle I.D. Numbers. The Senate added language requiring a database of VIN numbers. (Sec. 220)
- Construction Zone Enforcement. The Senate added language requiring \$500,000 to be used for construction zone traffic enforcement. (Sec. 905)
