

SENATE BILL No. 828

October 19, 1999, Introduced by Senators ROGERS, BULLARD, MC MANUS and HAMMERSTROM and referred to the Committee on Transportation and Tourism.

A bill to amend 1949 PA 300, entitled "Michigan vehicle code," (MCL 257.1 to 257.923) by adding section 811m.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 SEC. 811M. (1) THE SECRETARY OF STATE SHALL DEVELOP UNDER
2 SECTION 811E AND, UPON APPLICATION, MAY ISSUE UNDER SECTION 811F
3 A STATE-SPONSORED MICHIGAN VETERANS MEMORIAL FUND-RAISING REGIS-
4 TRATION PLATE AND A MATCHING STATE-SPONSORED MICHIGAN VETERANS
5 MEMORIAL COLLECTOR PLATE AS PROVIDED UNDER SECTION 811G. THE
6 PLATE SHALL BE OF A DESIGN AS DETERMINED BY THE SECRETARY OF
7 STATE.

8 (2) MICHIGAN VETERANS MEMORIAL FUND-RAISING REGISTRATION
9 PLATE DONATIONS COLLECTED UNDER SECTION 811F AND MATCHING
10 MICHIGAN VETERANS MEMORIAL COLLECTOR PLATE FUND-RAISING DONATIONS
11 COLLECTED UNDER SECTION 811G SHALL BE DISBURSED UNDER SECTION

1 811H BY THE SECRETARY OF STATE TO THE STATE TREASURER, WHO SHALL

4 MEMORIAL ACT, 1988 PA 234, MCL 35.1053. THESE FUNDS SHALL BE

8 (3) FOR PURPOSES OF THIS CHAPTER, "MICHIGAN VETERANS MEMO-
9 RIAL FUND-RAISING REGISTRATION PLATE" MEANS A REGISTRATION PLATE
10 CONTAINING A SPECIALIZED DESIGN PERTAINING TO MICHIGAN VETERANS.

11 Enacting section 1. This amendatory act takes effect
12 October 1, 2000.

13 Enacting section 2. This amendatory act does not take
14 effect unless Senate Bill No. 826
15 of the 90th Legislature is enacted into
16 law.
