- 1 Sec. 8801. (1) This chapter applies only to a state civil
- 2 infraction action involving a violation of state law that is des-
- 3 ignated as a state civil infraction.
- 4 (2) This chapter does not apply to a civil infraction action
- 5 involving a traffic or parking violation.
- **6** (3) As used in this chapter:
- 7 (a) "Citation" means a written complaint or notice to appear
- 8 in court upon which a law enforcement officer records the
- 9 occurrence or existence of 1 or more state civil infractions by
- 10 the person cited.
