## **HOUSE BILL No. 4379**

A bill to amend 1990 PA 319, entitled

"An act to prohibit local units of government from imposing certain restrictions on the ownership, registration, purchase, sale, transfer, transportation, or possession of pistols or other firearms, ammunition for pistols or other firearms, or components of pistols or other firearms,"

by amending the title and section 1 (MCL 123.1101) and by adding sections 6 and 7.

- 6 (B) A CIVIL ACTION BY A PERSON AGAINST THE PRODUCER OF A
- 7 PISTOL OR FIREARM FOR BREACH OF CONTRACT OR WARRANTY INVOLVING
- 8 PRODUCTION OF THE PISTOL OR FIREARM.
- 9 (3) IF THE COURT DISMISSES AN ACTION AGAINST A PRODUCER,
- 10 OWNER, OR POSSESSOR OF A PISTOL OR FIREARM BASED ON A PROHIBITION
- 11 OR IMMUNITY PROVIDED IN SUBSECTION (1), THE COURT SHALL AWARD
- 12 EACH DEFENDANT DISMISSED FROM THE ACTION COSTS ON THAT BASIS AND
- 13 REASONABLE ATTORNEY FEES.
- 14 SEC. 7. A GOVERNMENTAL ENTITY SHALL NOT REQUIRE A PERSON
- 15 WHO PRODUCES, OWNS, OR POSSESSES A PISTOL OR OTHER FIREARM TO
- 16 INSTALL A SAFETY DEVICE OR TO PUT A WARNING OR SAFETY LABEL ON A

- 17 PISTOL OR FIREARM, OR ON PACKAGING OR A CONTAINER IN WHICH A
- 18 PISTOL OR FIREARM IS SOLD OR TRANSPORTED.
