## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 2837. (1) THE DEPARTMENT SHALL DO ALL OF THE
- 2 FOLLOWING:
- 3 (A) PROMULGATE RULES REQUIRING A PHYSICIAN TO FILE A WRITTEN
- 4 REPORT WITH THE LOCAL PUBLIC HEALTH DEPARTMENT REGARDING A
- 5 PATIENT WHO COMES UNDER THE PHYSICIAN'S PROFESSIONAL CARE AND WHO
- 6 SUFFERS A PHYSICAL COMPLICATION OR DEATH THAT IS A PRIMARY, SEC-
- 7 ONDARY, OR TERTIARY RESULT OF AN ABORTION.
- 8 (B) SUMMARIZE AGGREGATE DATA FROM THE REPORTS REQUIRED UNDER
- 9 SUBDIVISION (A) FOR PURPOSES OF INCLUSION INTO THE ANNUAL
- 10 STATISTICAL REPORT ON ABORTION REQUIRED UNDER SECTION 2835.
